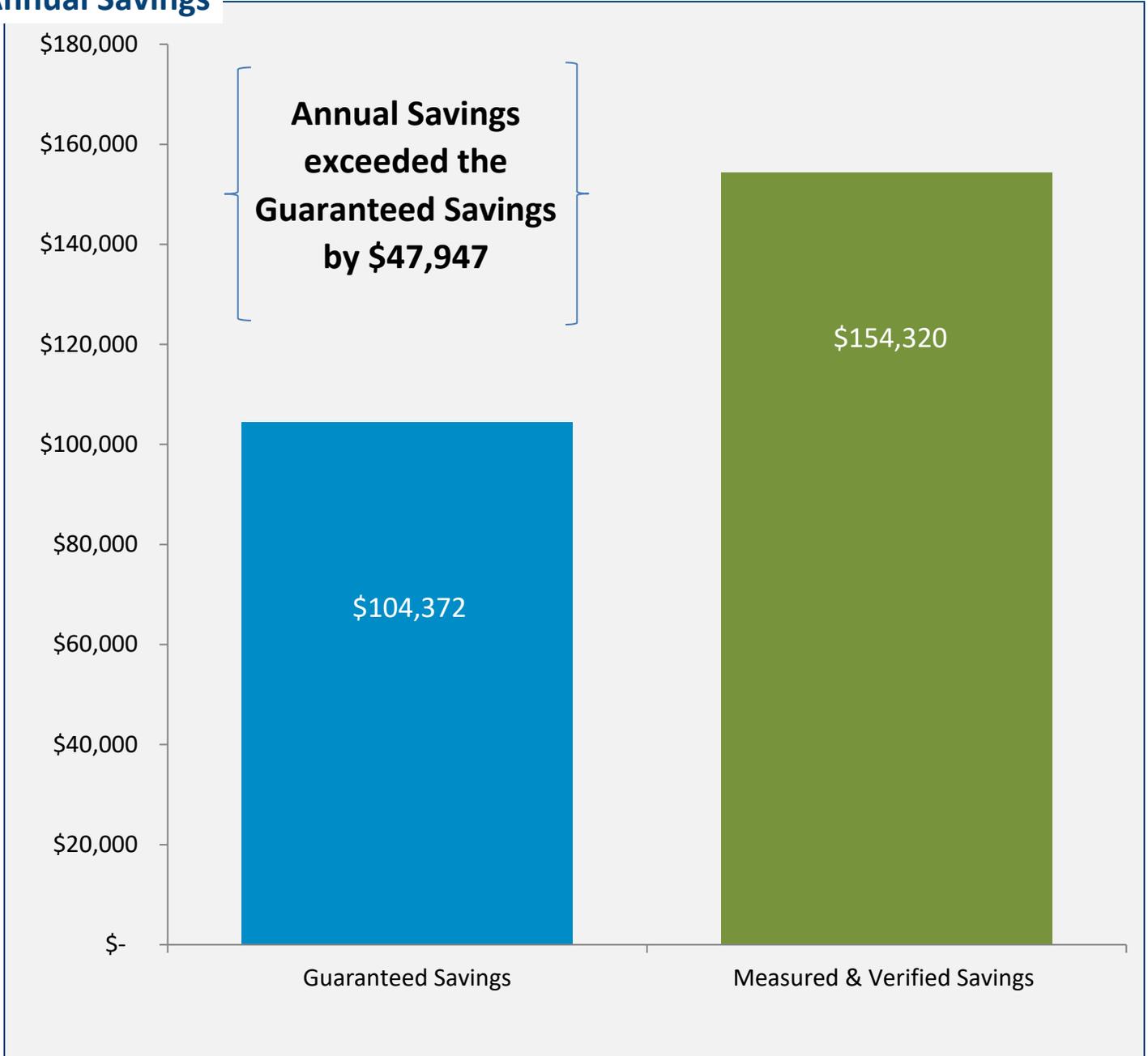

Executive Summary

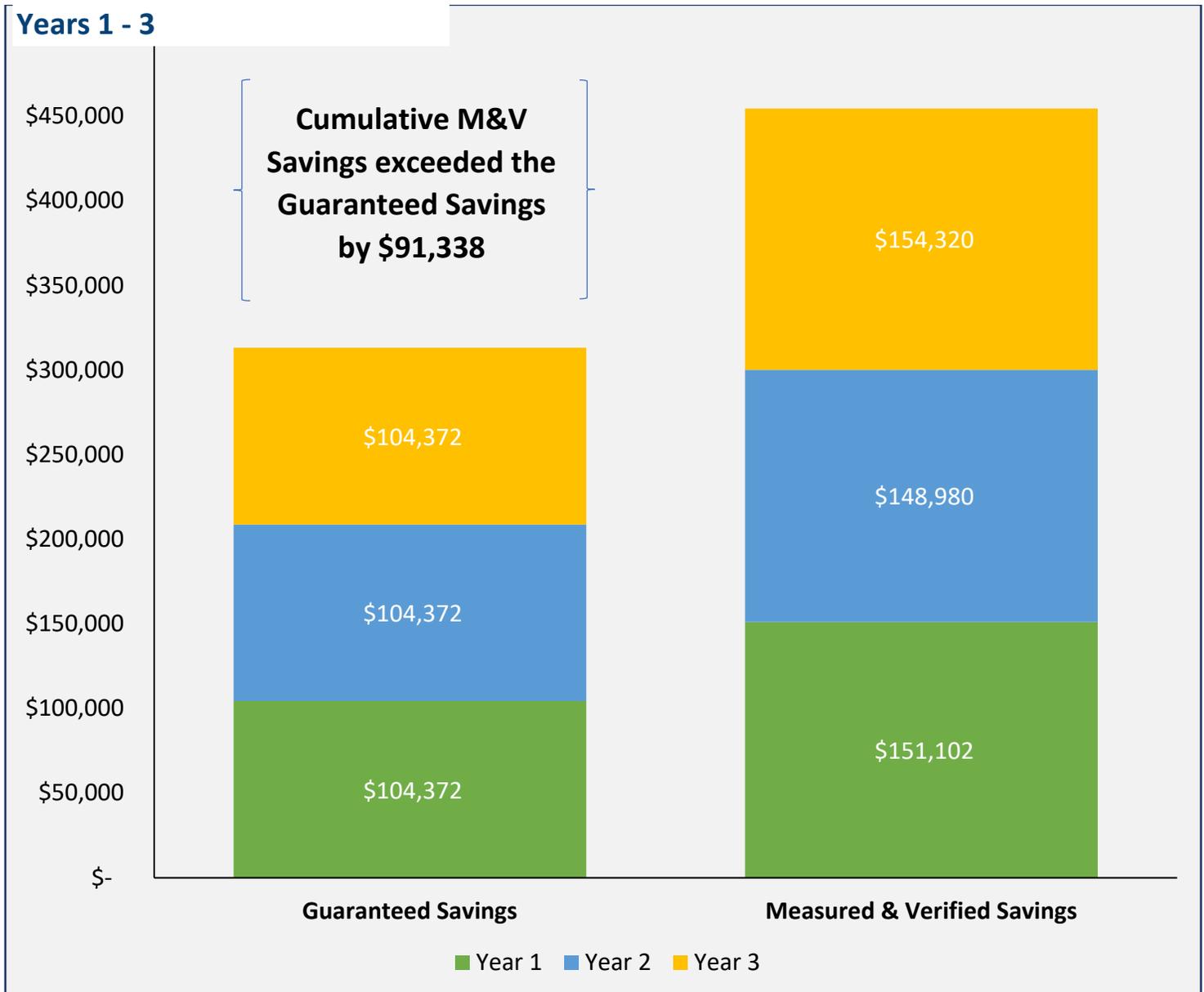
This Year 3 Annual Report provides an overview of energy performance resulting from the efficiency project completed by Performance Services (PSI) in 2019. Our Performance Assurance team is committed to measuring and monitoring project performance, recognizing customer successes, and identifying opportunities for increased efficiency. The following Annual Savings table shows guaranteed energy savings compared to actual savings measured for the period of July 1, 2021 – June 30, 2022. Measured savings surpassed guaranteed savings by **\$49,947**, or **47.9%**.

The following Cumulative Project Savings table shows guaranteed energy savings compared to actual measured savings throughout the life of the project, or July 2019 – June 2022. Measured savings surpassed guaranteed savings by **\$141,286**, or **45.1%**.

Project Description

Garrard County Schools in Lancaster, KY was looking to implement solutions to address their facilities' energy and operational savings, maintainability, and learning environment needs. In 2017 the District partnered with Performance Services to improve the energy efficiency of their 11 buildings, address their aging systems, and improve the learning environment for students and faculty.

- Installation of new heating, ventilation, and air-conditioning systems (HVAC) at the Garrard Education Center
- Installation of new high-efficiency boilers installed at the Middle School and the Area Tech Center

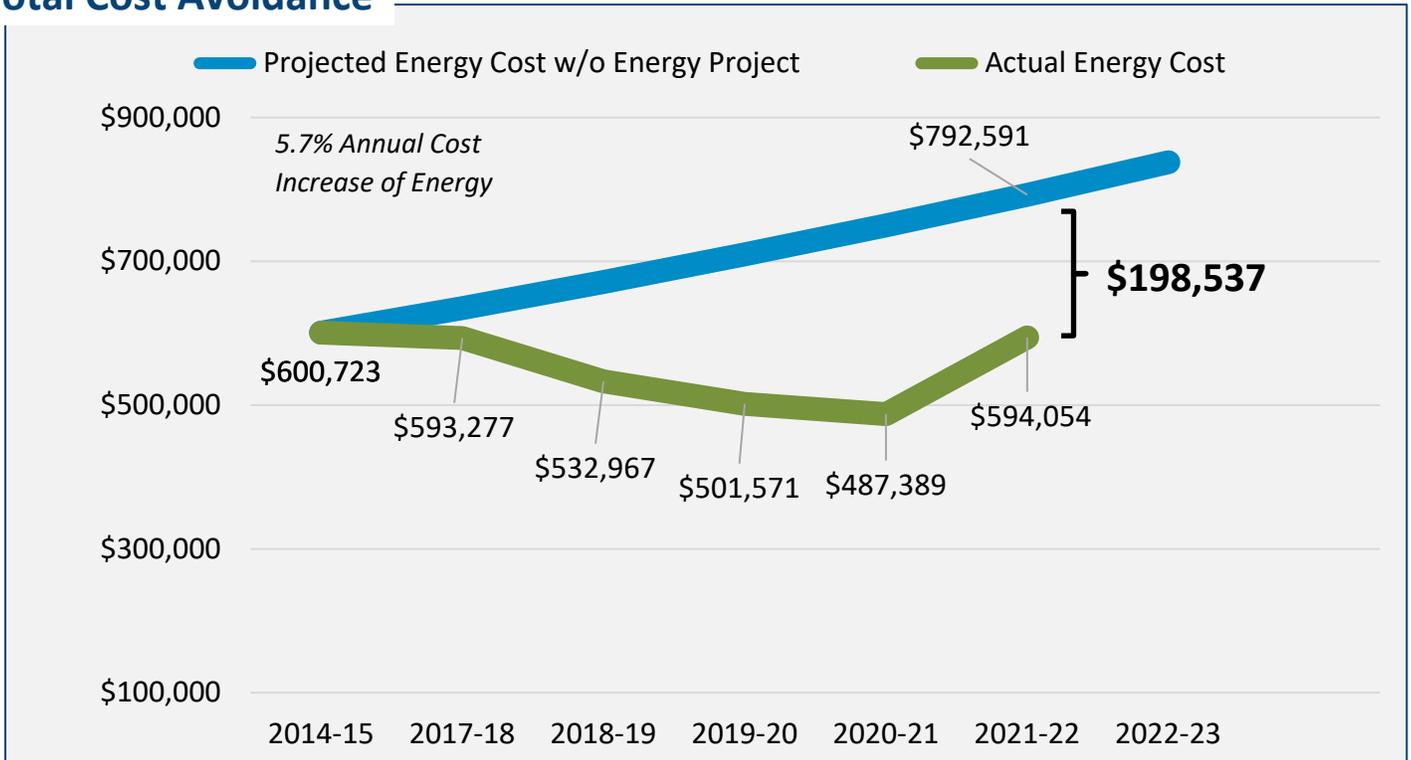

Financial Impact of the Project

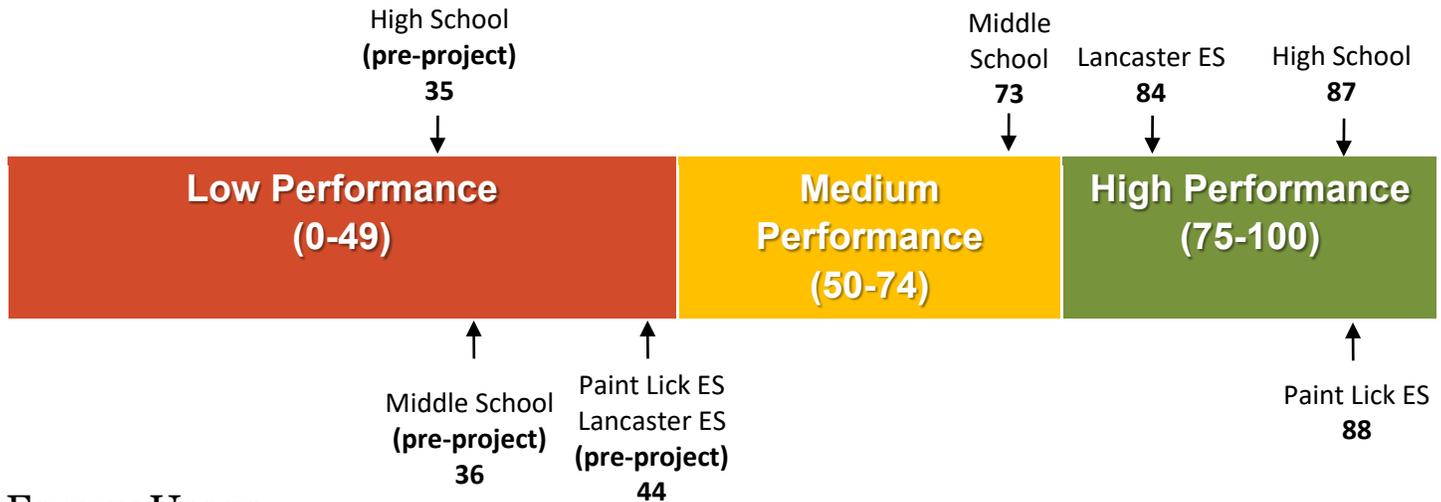
The avoided cost calculation examines projected energy expenditure had the district chosen not to upgrade equipment and adopt new consumption habits through the Energy Leadership program. This metric is demonstrated by applying actual utility rate inflation to pre-project equipment performance and usage. As shown in the following chart, Garrard County Schools avoided \$198,537 in energy costs during the third full year following project implementation.

Energy Impact of the Project

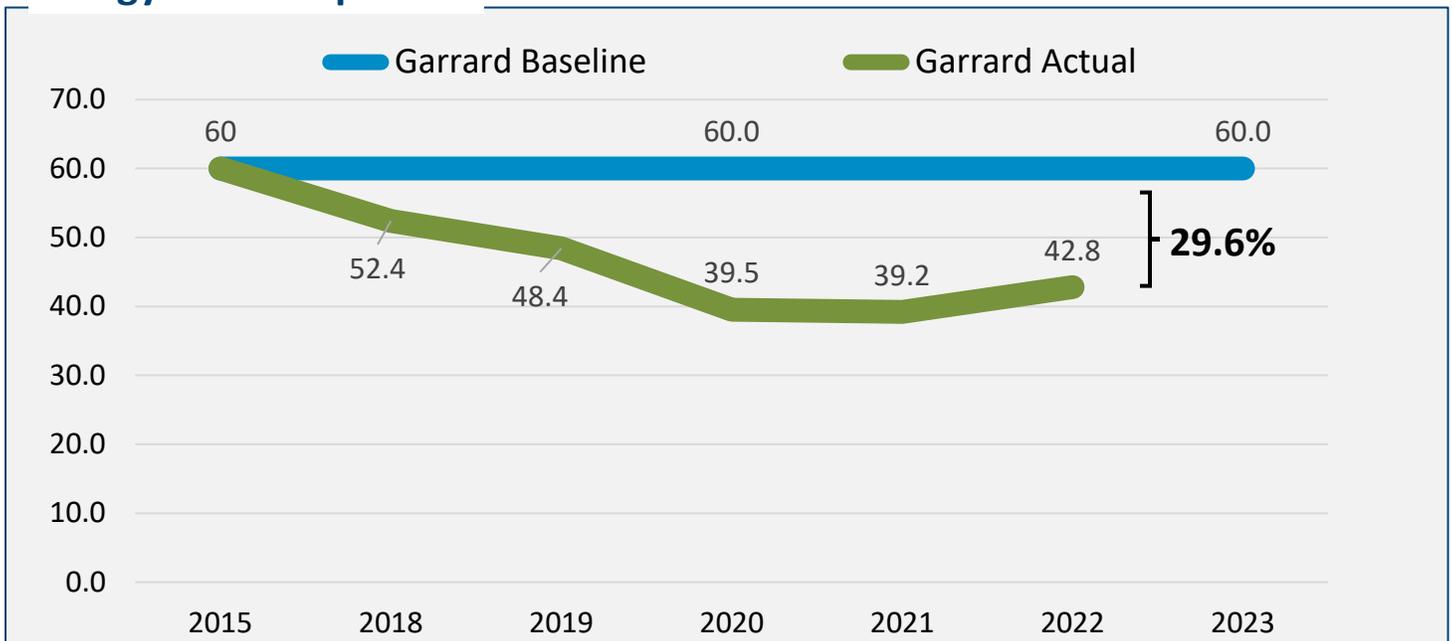
A widely adopted metric used to gauge energy impact is the ENERGY STAR score. ENERGY STAR, a federal program administered by the Environmental Protection Agency, provides recognition to facilities that meet their enhanced criteria for energy efficiency and indoor quality standards. Each facility is scored on a scale from 0 to 100 based on a variety of indicators like facility function, local climate, hours of operation, and the number of occupants. A building must achieve a score of 75 or better in order to qualify for ENERGY STAR certification. The chart below illustrates the improvement of your facilities' that are candidates for ENERGY STAR certification.



Energy Usage

The Energy Use Index (EUI), referred to generally as “energy intensity,” demonstrates the volume of energy consumed per square foot at a set of facilities over the course of a year. Prior to 2019, the Garrard County facilities included in this project scored a combined EUI of 60. After equipment upgrades and Four-Season Optimization, the EUI of these facilities is now 42.8, which is a 29.6% reduction in energy intensity.

Energy Use Comparison

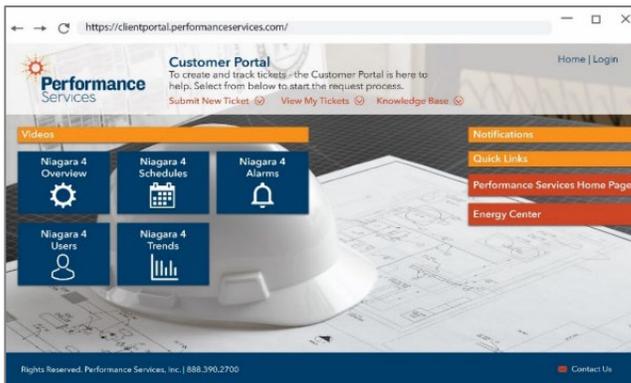


Customer Portal

Ticket Excerpts

7/1/2021, Bradley Abee submitted a ticket stating that the High School kitchen unit continually trips out and unit is not able to cool properly. PSI logged into the control system and conducted testing. We found that the issue was relating to a mechanical problem with a refrigerant device and not relating to the temperature controls. The school then coordinated the mechanical repairs and PSI closed the ticket.

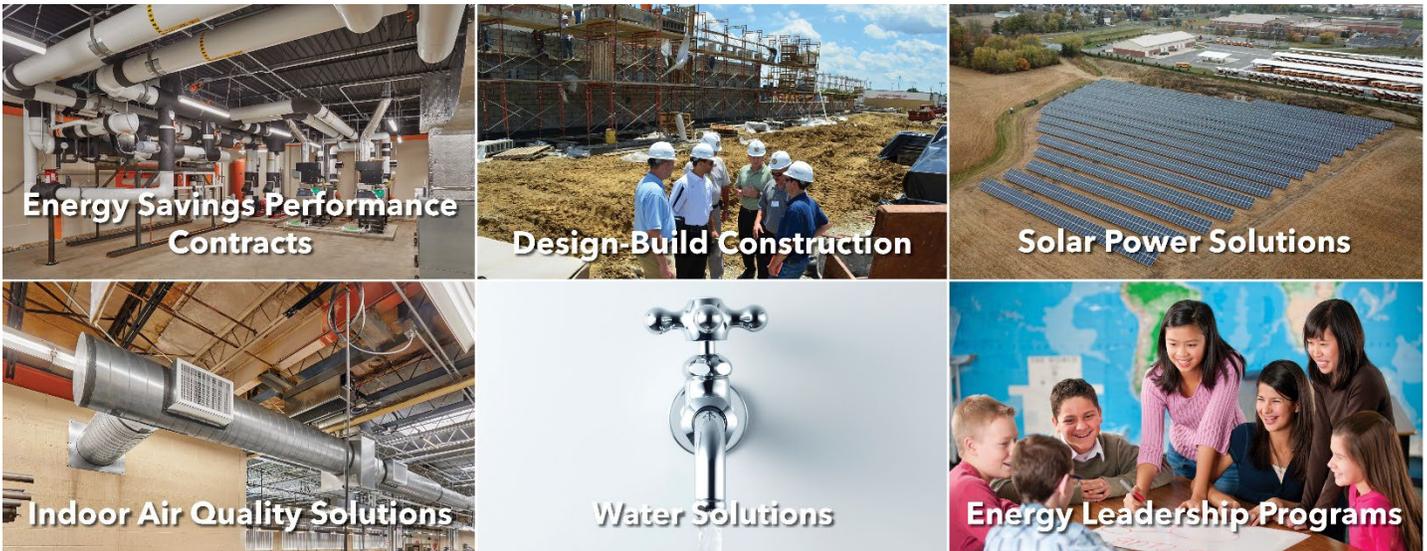
9/9/2021, Derek Johnson submitted a ticket stating that a thermostat at Camp Dick Robinson Cafeteria had failed. On 9/13/2021, PSI provided a quote for a new thermostat, received purchase order from the school, and placed the order for replacement.

3/1/2022, Bradley Abee submitted a ticket stating that the exterior lighting at Paint Lick ES is not working. Later that day, PSI logged into the control system and verified that the controls and BAS scheduling for the lighting was working properly and that the issue was relating to existing wiring within the building. The school then coordinated the troubleshooting with their preferred electrician.

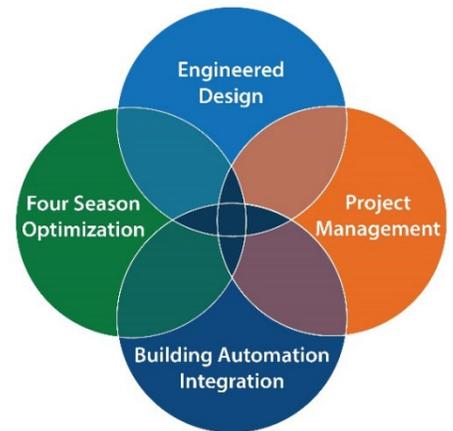

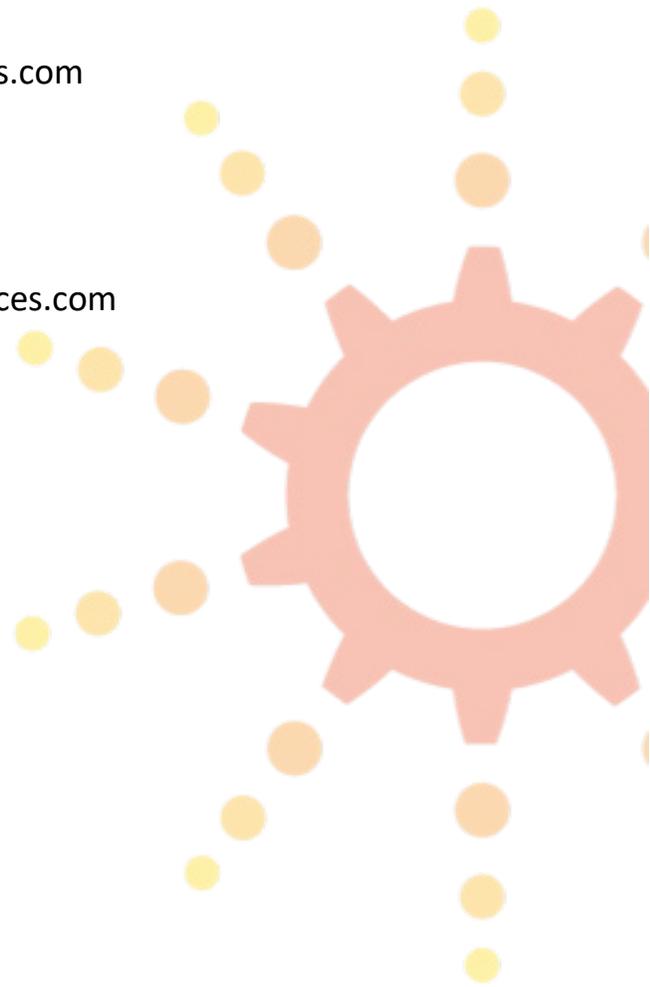
