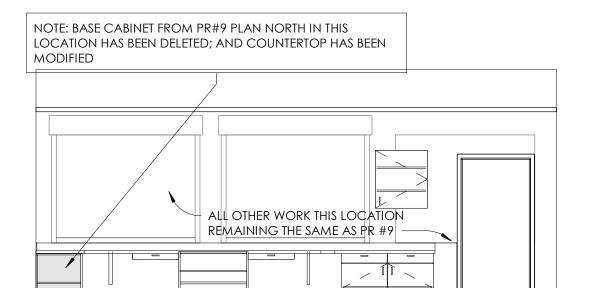




PR#26 -CONCESSION PLAN WEST

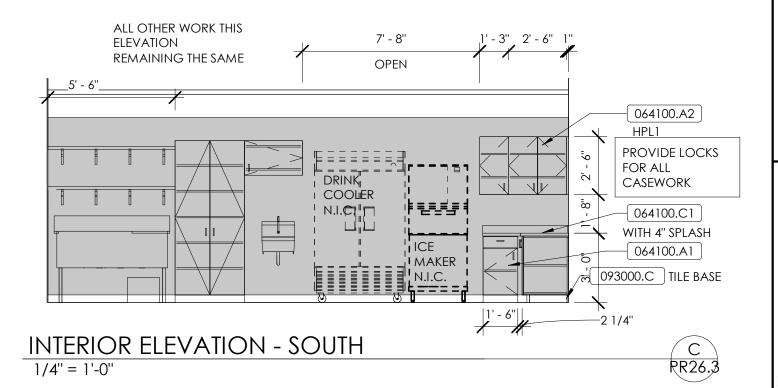

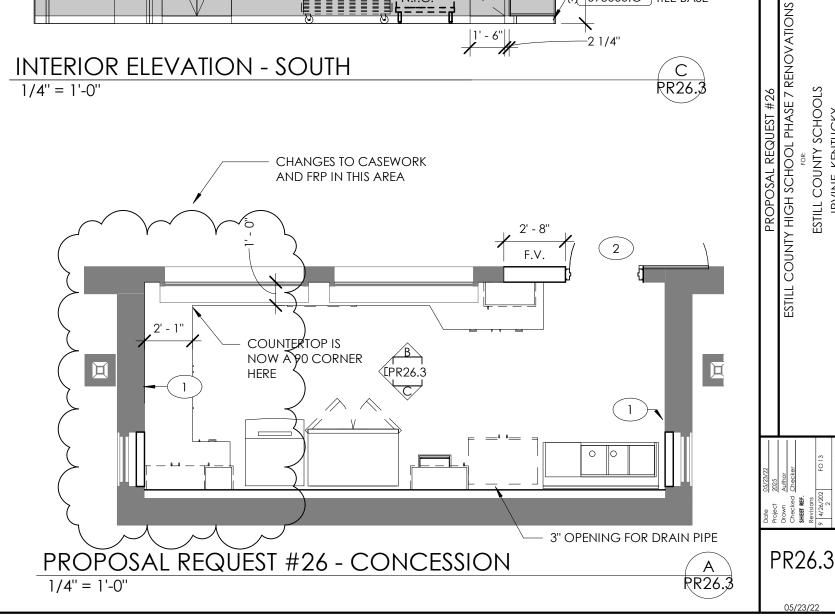


INTERIOR ELEVATION - NORTH
