Following are status reports on the following projects:

# BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

This project is continuing to work through closeout as we wait for Century to submit their request for final payment along with the appropriate affidavits and documentation.

# BOONE COUNTY HIGH SCHOOL - DOOR MODIFICATIONS (BG #23-091 / REH #129-722)

The initial BG-1 has been approved by the Kentucky Department of Education. Bidding Documents will be presented for approval at the November board meeting with an anticipated project award at the first of the year.

# BOONE COUNTY HIGH SCHOOL – PHASE 1 ADDITION AND RENOVATIONS (BG #20-183 / REH #129-120-A)

Phase 1 of the renovations are nearing completion with Graybach performing the preliminary punchlists. In the upcoming weeks, the Architect, Consultants and Owner will perform their respective punchlists as well as backchecks by the Owner's commissioning agent.

# BOONE COUNTY HIGH SCHOOL - PHASE 2 RENOVATIONS (BG #21-295 / REH #129-121-A)

This project is nearing the completion of Phase 2 and moving into the next phase. By early November, Graybach should mobilize to the upper level of the back hallway with the entire first floor being complete. The bathroom renovations on both levels will be part of Phase 5 over Summer 2023.

Blau Mechanical was awarded the project and contracts and insurance are in process. Submittals have been reviewed and materials are on order with construction activities anticipated to take approximately one month. Blau will work around any District-scheduled activities as-needed.

# JONES MIDDLE SCHOOL - ADDITION AND RENOVATIONS (BG #21-202 / REH #129-121-B)

Ashley Construction continues to make good progress as the new addition is being buttoned up. In the near future, painting will begin along with final finishes. The primary goal right now is getting above ceiling and MEP work completed – there are some struggles trying to procure equipment relative to these trades.

### RISE ACADEMY (ACE) - RENOVATIONS (BG #21-131 / #129-1020-A)

This project is in its final stages of completion. Closeout continues to be finalized with documentation being verified before turnover to the District for their use.

## RYLE HIGH SCHOOL - BAND TOWER (BG #21-120 / REH #129-621)

The initial BG-1 has been sent to the District but is currently on hold for funding options.

## RYLE HIGH SCHOOL - FENCING (BG #21-120 / REH #129-920)

The BG-4 has been approved by the Kentucky Department of Education and the final BG-5 project closeout form is being presented for approval at this month's meeting.

# RYLE HIGH SCHOOL - FLOORING UPGRADES (BG #22-255 / #129-421-D)

Weekly meetings are being held on-site with Surfaces Central to monitor construction progress. The project is to be complete by the end of this month, working around any District-scheduled activities as-needed.

### RYLE HIGH SCHOOL – POLE VAULT (BG #22-387 / REH #129-1121)

Weekly meetings are being held on-site with Riegler Blacktop to monitor construction progress. The posts are being installed this week with the mesh to follow once the concrete has cured. The fence installation is also anticipated to be complete this week. Punchlist will be performed upon completion of construction.
