# Phase 1

*Strategic Team Members capacity building*

Objective:

**To accommodate the growth and development of the team's technical and cooperative capabilities**

Objective:

**To promote CTE Exceptional Education Program as the exemplary program known for providing support and opportunities for CTE students with disabilities.**

Tasks:

- **Transition Evaluation**
- **High school scheduling at GMS**
- **Post-Secondary Transition Plan completion for all students with IEPs**
- **Increased CTSO participation for students with IEPs**
- **Compilation of potential work-based learning opportunities**

**Continued work on building knowledge of CTE and Program of Studies.**


