1. 2022 KDE Parent Survey Results

The Kentucky Department of Education, Office of Special Education (OSEEL), is responsible for conducting an annual survey of parents who have a child with a disability, ages 3-21, to determine how schools are supporting parent involvement in their child's special education services. The survey is conducted as part of a federal requirement for Kentucky's State Performance Plan for Special Education (SPP), Indicator #8: Parental Involvement Survey. Every school district in Kentucky is required to participate in the survey.

Parents' names and children's names will not appear on the survey or on any report that is generated as a result of the survey. Because the information from all surveys must be summarized for each district as well as for the entire state, a tracking number is assigned to each survey. The results for each participating district are publicly reported and used to improve parental involvement and guide decisions regarding special education programming.

This year's parent survey results indicate Newport is above state averages in all parent ratings with the exception of one category. When rating the degree of involvement in their child's education the state rate was 69.02% and Newport's 65.08%.

Newport is at 100% for the following:

- Parent's felt that the school involved them in a meaningful way to improve services and results for their child.
 - Parent's felt that the school staff welcomed them to participate in the planning of their child's special education services.
 - Parent's of students 14 years of age and older indicated the school prepared their child for future employment.
