- a. Assessing Student Achievement
 - a. Updated Post-Secondary Numbers
 - i. We are currently at 37/61 students postsecondary. At this time last year we were 16/54. Our goal is 85%. There are clear pathways for 8 students to gain postsecondary readiness and all students have an individualized plan to get to postsecondary readiness.
 - b. Dual Credit Course Breakdown
 - i. 141 dual credit courses are being taken this semester. 15 students are at NKU, 3 students are in the logistics program, and 30 students are at Gateway in their general studies program.
