Division 02: Existing Conditions

02.01: 2022.10.05 – The failed concrete slab outside of the baseball concessions building had been removed.

Division 03: Concrete

03.01: 2022.09.21 – Foam backfill blocks were being delivered to the site.

03.02: 2022.10.05 – Temporary shoring at the pool cantilevers was identified as being deficient. Additional shoring was required.

Division 04: Masonry

04.01: 2022.09.21 – The backstop at the baseball field had been built. Cast stone cap was yet to be installed.

04.02: 2022.10.05 – Two brick veneer mockups were completed for review. A mortar selection was made. 04.03: 2022.10.17 – Masons were actively working in the athletic locker room area (inside the original building footprint). Masons were actively installing base of wall flashing in preparation of starting brick veneer.

04.04: 2022.10.19 – Masons were actively working on brick veneer at the North end of the practice gym and were also working on concrete masonry inside the pool lobby.

Division 05: Metals

05.01: 2022.10.05 – Steel beams had been installed at the pool equipment room roof. The first of the three major pool trusses had been installed.

05.02: 2022.10.17 – Cold form metal framing had been erected at the pool entry and West facing two-story wall of the pool space.



05.03: 2022.10.17 – Roof deck was actively being installed above the monumental stair portion of Area B. The Northern most major truss had been installed at the pool space.

05.04: 2022.10.19 - Roof deck had been installed over the pool equipment room.

Division 06: Woods and Plastics

06.01: 2022.09.21 - Dugout ceilings had been installed. Trim work was in progress at the home dugout.

Division 07: Thermal and Moisture Protection

07.01: 2022.09.21 – Fluid applied air/weather barrier had been applied from the West edge of the pool space around to the mid-point of the West wall of the practice gym.

07.02: 2022.10.17 – Most of the practice gym had been dried-in. Insulation was staged in advance of metal deck installation.

Division 08: Doors and Windows

08.01: 2022.10.17 – Door frames at locker rooms had been erected in advance of masonry work at in the original locker room area.

08.02: 2022.10.19 - The coiling door had been installed at the baseball storage building.

Division 31: Earthwork

31.01: 2022.09.21 – The French along the baselines and backstop was being installed. Work was more than half complete.

31.02: 2022.09.21 – Gravel base was being compacted at the sidewalk and bleacher pad on the home dugout side of the baseball field.

31.03: 2022.10.05 – The French drain at the baseball field was complete.

31.04: 2022.10.05 - Rough grading was actively occurring at the Taylor Mill site.

31.05: 2022.10.19 – Rough grading (of the area currently available for work) was largely complete at the Taylor Mill site. Erosion control measures were in place. The detention basin was established. Storm piping was staged for installation and sever storm structures as well.

Division 32: Exterior Improvements

32.01: 2022.09.21 – Fence post installation was complete at the baseball field.

32.02: 2022.09.21 – Concrete flatwork was complete from the ticket shad structure to the home plate end of the visitor dugout.

32.03: 2022.09.21 – A portion of the lot North of Woodland had been paved and was being used for contractor parking. The wearing course/topping had been installed at the athletic parking lots and tennis courts. Striping was complete at the athletic lots.

32.04: 2022.10.05 – Warning track material was in the process of being distributed.

32.05: 2022.10.05 – 30% of the baseball grandstand had been poured, along with the sidewalk behind the home dugout. The portion behind home plate had rebar in place and was formed, in preparation for being poured.

32.06: 2022.10.17 – Fence fabric was actively being installed at the baseball field and was approximately 40% complete. Fence fabric at the tennis courts was 90% complete.

32.07: 2022.10.17 – Fine grading of the baseball field appeared complete and was awaiting sod. Irrigation appeared all but complete. Warning track appeared complete and was being used as the working surface for fence fabric installation.

32.08: 2022.10.19 – Fence fabric installation was 90% complete at the baseball field.








