HISTORY/BACKGROUND:

This is the fourth (4th) change order for the White's Tower Addition and Renovation Project associated with Graybach Construction. The original contract was \$4,493,955.00. This change order for an additional \$69,589.99 with previous change orders of \$84,199.03 makes the new contract sum \$4,647,744.02.

Item No. 04-01 (PCO 01)

Provide 6" resilient base in lieu of structural glazed tile base

Cost Benefit to Owner: Owner requested change due to lead time issues with obtaining the structural glazed tile within the construction timeframe DEDUCT: \$9,033.42

Item No. 04-02 (PCO 30)

Delete fencing around the future generator location

Cost Benefit to Owner: Owner requested change. Fence will be installed when generator is installed in the future. Credit is for labor only. Material will be used at a new area at the playground

DEDUCT: \$200

Item No. 04-03 (PCO 38)

Add hydronic backflow preventor

Cost Benefit to Owner: Backflow preventor necessary for proper operation of hyrdnoic piping

ADD: \$1,649.10

Item No. 04-04 (PCO 41)

Reroute condensate drain for Preschool Classroom blower coil units to exterior drywells

Cost Benefit to Owner: Room originally identified for piping to drain to did not have a drain and sink for piping to drain to.

Piping condensate was the most cost effective option to drain the condensate for the units ADD: \$2,126.71

Item No. 04-05 (PCO 42)

Provide water supply and return piping to air curtain HVAC unit in Kitchen

Cost Benefit ot Owner: Piping wasn't indicated on HVAC drawings. Piping is needed for unit to function

ADD: \$12,084.25

Item No. 04-06 (PCO 46)

Remove existing chainlink fence at portion of playground and provide new due to new grade elevations of site around playground

Cost Benefit to Owner: New fence location and height is better suited for new paved and mulched playground location to simplify long term maintenance of the grounds around the fence

ADD: \$10,100

Item No. 04-07 (PCO 47)

Cut new opening in masonry wall and install new door from corridor to Cafeteria

Cost Benefit to Owner: Owner request to facilitate better flow of students going to and from lunch serving line

Cost Benefit to Owner: Owner request to add french drain to allevaite past water drainage issues at the playground ADD: \$10,337.35

Item No. 04-09 (PCO 49)

Provide rubber mulch in lieu wood mulch indicated on bid documents for the Preschool playground

Cost Benefit to Owner: Owner request for rubber mulch in lieu of wood for better longevity and safety of the children

ADD: \$2,903.75

Item No. 04-10 (PCO 50)

Provide duct smoke detectors at cafeteria/gym HVAC units per building department request Cost Benefit to Owner: Building department required devices in order to grand Certificate of Occupancy ADD: \$7,602,02

Item No. 04-11 (PCO 51)

Provide sod in lieu seed/straw at playground area

Cost Benefit to Owner: Owner requested to allow for quicker use of the playground without the children going thru mud

ADD: \$19,350,59

Item No.04-12 (PCO 54)

Remove pumps from rear of existing boilers

Cost Benefit to Owner: New pumps were added to the front of the existing boilers for better control of the system. Removal of the existing pumps provides better operation of the boilers as the existing pumps would have added additional head load pressure to the new pumps.
