#### **HISTORY/BACKGROUND:**

This is the seventh (7<sup>th</sup>) change order for the Scott High School Phase V, Taylor Mill Site Circulation, and Woodland Middle School Addition and Renovation Project associated with Morel Construction. The original contract was \$31,401,986.00. This change order for an additional \$33,143.00 with previous change orders of \$176,332.00 makes the new contract sum \$31,611,461.00.

Item No 1: Furnish and install revised grades at the baseball field to provide a shallow diversion drain around the infield and cut slope at right field warning track; provide revised concrete slab under bleachers behind backstop.

Furnish and install revised grades at the baseball field to provide a shallow diversion drain around the infield and cut slope at right field warning track; provide revised concrete slab under main bleachers behind backstop. General Contractor and Architect's Request.

Cost Benefit to Ower: Eliminates warning track wash-out concern in right field, prevents outfield run-off from running through infield, improves water management between backstop and concession stand, and addresses maximum slope under bleachers as required by manufacturer.
