Special Education Update:

The NKCES DoSE Advisory Board met on October 25. The NKCES DoSE Meeting was held on October 28. Topics of discussion included KDE's Office of Special Education and Early Learning (OSEEL) new Indicator Guide, Fiscal Monitoring, etc. Mr. Jonathan Compton from OSEEL was present and reviewed OSEEL's Fiscal Monitoring Requirements.

Mrs. Becky Nixon led the Special Education Regional Technical Assistance Center (SERTAC) State Directors Meeting on October 11. OSEEL was present and shared updates and upcoming important dates.

Mrs. Becky Nixon and Mrs. Amanda Bell met with the Director of Unified Champion Schools on October 14 to plan a state-wide information session regarding becoming a Unified Champion School. This information session is scheduled for November 30th from 3:30 to 4:30.

Mrs. Becky Nixon attended the KYCASE Executive Board Planning Meeting on October 25. The board worked on planning for the KYCASE Spring Institute which is March 23 and KYCASE Summer Conference which is July 17-18.

The NKCES Preschool Coordinator's Meeting was held on October 26. Topics of discussion included the new OSEP Dear Colleague Letter on IDEA Services in Head Start, Child Outcomes Summary (COS) Process, etc.

The NKCES Special Education Regional Technical Assistance Center (SERTAC) is excited to announce they were awarded the FY23 American Rescue Plan Transition Grant (ARP TG). This grant offers \$220,000 in funding for the SERTACs to develop a program to support districts in providing learning opportunities to overcome the challenges of the Covid pandemic as it relates to post-secondary transition.

The SERTAC team continued completing compliance record reviews in several districts. In addition, the SERTAC continued to provide coaching and support for teachers and administrators across the region.

Mrs. Amanda Bell and Dr. Merissa Waddey continue the partnership with the KY Autism Training Center (KATC) to support two regional training sites.

Mrs. Becky Nixon and Mr. Jarrod Slone from OSEEL continued to provide assistance to districts related to significant disproportionality.

Dr. Merissa Waddey continues to plan with the KYCEC Conference Committee to facilitate the 56th Annual KY Exceptional Children's Conference in Louisville, KY on Nov. 20-22. Their New Teacher Academy will provide KAR-required professional development for emergency/probationary teachers.

Mrs. Becky Nixon and Dr. Merissa Waddey hosted Dr. Scott Yaruss on Oct. 31 for School-Age Stuttering Therapy: A Practical Approach. Dr. Yaruss delivered this critical 6-hour training for 115 Speech-Language Pathologists statewide.



The IDEA consultants attended their respective monthly state group meetings. Mrs. Becky Nixon continues to lead the state Low Incidence Task Group.

Learning and Empowerment Team:

The Learning and Empowerment team worked with over 390 educators and 20 districts this month.

The CRRSA team partnered with 12 districts and served 348 Northern Kentucky educators. The Learning Acceleration team led professional learning on Reading and Writing Standard Clarity, MTSS, Learning Acceleration, Writing Across the Curriculum and Differentiation. The Social Emotional Learning team led professional learning on Tier 1 Behavior Strategies, Compassion Resilience, Positive Narration and Precise Directions, Trauma Informed Practices and Community Meetings. They also provided a book study to two schools on the book *Every Student, Every Day*.

Learning Acceleration Specialist (LAS) Amelia Powers led a statewide book study for cooperative coaches on The PD Book and participated in the UK Next Gen Leadership cohort. Both teams participated in the monthly statewide CRRSA meetings and continued work on an SEL Implementation Guide and MTSS Academic supports.

The Deeper Learning team worked with districts to either continue developing or start supporting the district Deeper Learning plans. The team also participated in statewide Deeper Learning meetings, the UK Next Gen Leadership cohort and attended the Science of Learning Training and the Aurora Institute Symposium.

Mr. Henry Astudillo, NKCES DEI Specialist, partnered with KDE and Engage 2 Learn for a training with Boone County school and district leaders on Equity Playbook coaching. He continued to engage in coaching meetings with those leaders throughout the month.

Mr. Joe Bertucci of The Northern Kentucky Institute for Arts in Education attended the Educational Theatre Association's national conference, bringing new ideas and connections back to our region. He also met with the federal program officer for our Assistance for Arts Education grant, which began its second year on October 1. Schools participating in our AIM program are receiving arts supplies to meet needs on their comprehensive arts plans, and 32 videos have been published and shared to support arts education across our region.

The Northern Kentucky Institute for Strategic Prevention partnered with 7 community organizations and 10 districts this month. The team attended the Too Good for Drugs and Violence training in Boston, Massachusetts and are now ready to bring the program to NKCES districts. The team hosted a regional steering committee meeting, a Catch My Breath training and participated in meetings with multiple community partners. Mrs. Christi Jefferds and Ms. Abby Beausir presented and hosted a session at the NKY Youth Vaping Summit and provided t-shirts for all attendees. The team also distributed over 50,000 promotional items and resources to NKCES member schools in anticipation of Red Ribbon Week.



The CEO II Program partnership with KEDC, WKEC and BloomBoard is working with interested teachers and districts to create a January cohort. Interested teachers will meet with all three cooperatives for one onboarding call on November 1st or November 2nd. The team has monthly meetings for existing mentors, and those were held on October 26th and 27th.

Grant Consortium Update:

\$10,000,000+ in grant applications funded in October: Bellevue Schools, approximately \$1.875 million over five years, from Strategic Prevention Framework-Partnerships for Success; Campbell County Schools, approximately \$3.8 million over four years for Trauma Informed School Services; Covington Independent Public Schools, approximately \$680,000 over three years for Mentoring for Youth Affected by Opioids; NKCES on behalf of Bellevue, Boone County, Carroll County, Dayton, Grant County, Kenton County, Ludlow, Pendleton County, Southgate, and Williamstown, \$3.88 million over four years for Trauma Informed School Services. NKCES Special Education was awarded a Transition Grant from KDE. Congratulations to all who worked so hard to put these plans in place!

<u>Trauma Informed School Services</u> implementation has begun! Ms. Michelle Klein will be the Project Director and she and Vicki Dansberry met online with the Washington project officer to get beginning directives. From here, Michelle will serve as district contact for this project until a Coordinator is hired.

Collaborative Grants Submitted: Full Service Community Schools, two applications (<u>Covington/Newport</u>); NKCES on behalf of <u>Bellevue</u>, <u>Campbell County</u>, <u>Dayton</u>, <u>and Ludlow</u>). Project Prevent: <u>Williamstown/Grant County</u>. NKCES on behalf of 19 districts, School Based Mental Health grant. American Rescue Plan Transition Grant in collaboration with NKCES Special Education.
