A. Discussion of 2023 JCPS Legislative Priorities

Chuck Truesdell, executive administrator, Government and Community Relations, presented a report regarding potential issues to be included in the 2023 JCPS Legislative Agenda. Each Board member was able to provide feedback and ask clarifying questions.

Mr. Marshall expressed frustration, stating that Kentucky legislatures do not acknowledge the good work happening in JCPS. He asked how Mr. Truesdell's interactions have been in Frankfort. He continued and said, "I support everything that's on these priorities. It's my hope that people start to realize the amazing things that are happening here and how we are growing and looking to improve and I hope that eventually they get on board and start helping our kids as well."

Mrs. Duncan acknowledged inadequate state funding and said, "A couple of areas that need funding that aren't on here, and I guess it's because it's not a funding year, but I want us to keep it in mind - we still need safety officers ... and we still need funding for our ESL population." She asked if there would be any discussion around the Read to Succeed Act. She asked for clarification regarding the securing of firearms.

Mr. Craig stated that he agrees with Mr. Marshall's comments. He then asked, "On the gun safety issue, have we had any further conversation about the *Mom's Demand Action* initiative that we've discussed preliminarily?"

Ms. McIntosh expressed frustration with state funding and pointed out that when our state legislature tells us that they have increased education funding, it is not entirely true for all districts. She then suggested they use specific language around vaping, in particular with families and advanced generations who may not be as aware of vaping or electronic cigarettes.

Dr. Kolb said that he agreed with everything on the list of priorities and asked, "Do we expect to see any legislation that targets LGBTQ+ kids like transphobic type of legislation? And if so, I'd like us to consider some position on that." He asked Mr. Truesdell his opinion on the list of priorities and if he thought it was a good balance or too much. Dr. Kolb was also frustrated with legislators' view/opinion of JCPS and asked, "How can we take what we're doing to them? I know you do that through presentations, but do we have students testify a lot ... or are there other ways that we could bring the work to them?"

Dr. Shull asked, "Are we flagging any legislation that may be opposed to diversity, equity, and inclusion policies that are housed in districts? He asked for clarification regarding legislation requiring secure storage of firearms and ammunition. He then asked if the priorities had gone through the Racial Equity Analysis Protocol (REAP).

Chair Porter said, "I appreciate that you have on the list, the Superintendent Screening Committee because that has been something that this district has tried to work on for a number of years. We almost got there once but then all of a sudden we weren't there. So, it's very important, I think, that the screening committee represents the student population of the district."
