SBDM Minutes
October 20, 2022

Meeting was called to order at 3:30 p.m.

Council reviewed the current agenda. Heather Goodman requested an addendum be made to the agenda to add SBDM December meeting date change. Alex Vega made a motion to approve the agenda with the addendum; motion was seconded by Karen Henson. All were in consensus.

Council reviewed the September meeting minutes. Karen Henson made a motion to approve the minutes; motion was seconded by Heather Paulsen. All were in consensus.

- Enrollment: 451
- Updates:
 - The Fall Festival was a great success. PTO was able to raise nearly \$9000.
 - Parent/Teacher conferences were held on 10/10. There was a great deal of positive feedback from parents on those.
 - MES Academic Team has had two competitions. We have wins against Helmwood and St. James School and a close loss to Heartland.
 - 1st grade took a field trip to Crawford's Farm.
 - On the 10/14 Early Release day, staff had productive conversations concerning KSA testing data.

 - 10/26 will be makeup picture day.
 - 10/28 is Halloween Party Day.
 - 11/4-11/11 will be the Scholastic Book Fair in the library.
 - 11/10 is Thanksgiving Lunch - families are invited to join their student.
 - 11/11 is the next Early Release Day.

Heather Goodman presented the Council with a year to date budget for Section 6, General Fund, and the School Activity account.

- Heather Goodman made a recommendation to Council to place additional September allocation money of \$580 into contingency. Alex Vega made a motion

to move additional funds into contingency; motion was seconded by Heather Paulsen. All were in consensus.

Heather Goodman reviewed 2022 KSA data with the Council.

Heather Goodman recommended that we transfer school activity funds from the donation account into District Activity Funds to purchase pouches to organize newly acquired leveled readers. Karen Henson made a motion to approve the transfer of funds; Sharon Billings seconded the motion. All were in consensus.
