- 11 developed under KRS 158.645, [and] 158.6451, and 158.6453. KRS 158.6453 requires the
- 12 revision of academic content standards. KRS 156.070(1) requires the Kentucky Board of
- 13 Education to manage and control the common schools and all programs operated in the schools.
- 14 KRS 160.290 authorizes local boards of education to provide for courses and other services for
- 15 students consistent with the administrative regulations of the Kentucky Board of Education. This
- 16 administrative regulation incorporates by reference the required academic standards, which
- 17 contain the general courses of study and academic content standards for use in Kentucky's
- 18 common schools unless specifically incorporated in another administrative regulation in Title
- 19 704, Chapter 8.
- Section 1. Before graduating from a Kentucky public high school, a student shall meet the
 minimum content requirements established in the required academic standards.
