HISTORY/BACKGROUND:

This is the seventh (7th) change order for the Beechgrove Addition and Renovation Project associated with Morel Construction. The original contract was \$3,252,761.00. This change order for a deduction of \$112.64 with previous change orders of \$223,061.39 makes the new contract sum \$3,475,709.75.

Item No 1: Delete electrical and data work in Office #1308 due to the room being used for a different purpose.

DEDUCT: \$ 1,136.64

Item No 2: Unload, assemble, and install additional casework beyond the cubbies detailed on the drawings.

ADD: \$ 1,024.00

TOTAL DEDUCT: \$ 112.64
