BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

This project is under review by the District for final payment and closeout.

BOONE COUNTY HIGH SCHOOL - DOOR MODIFICATIONS (BG #23-091 / REH #129-722)

Project has been awarded to to Kramer & Feldman with contracts and submittals in process. Regular progress meetings will be held to monitor construction activities once they are underway.

BOONE COUNTY HIGH SCHOOL - PHASE 1 ADDITION AND RENOVATIONS (BG #20-183 / REH #129-120-A)

This project is currently occupied and the Architect and Engineers have performed their preliminary punchlists. There are a lot of items for correction and in the next couple weeks Graybach will be making appropriate corrective actions.

BOONE COUNTY HIGH SCHOOL - PHASE 2 RENOVATIONS (BG #21-295 / REH #129-121-A)

Stapleton Electric has completed all work except for installation of some exit signs – the signs have now been received and installation is being coordinated with the District. Final walkthroughs and punchlist will take place in the near future.

BOONE COUNTY SCHOOLS - HVAC CONTROLS (OCKERMAN MIDDLE, NEW HAVEN) (BG #22-250 / REH #129-1021-A)

Project has been awarded to Siemens Industry and contracts and submittals are in process. Progress meetings are being held on a weekly basis to monitor construction activities.

ERPENBECK ELEMENTARY SCHOOL - ROOFING (BG #21-165 / REH #129-1220-A)

KDE's approval of the BG-4 has been received and the final BG-5 Project Closeout form is being presented for approval at this month's meeting.

GRAY MIDDLE SCHOOL - COOLING TOWER PIPING (BG #22-248 / REH #129-1021-B)

The cooling tower has been raised and reset. There are some controls and final tie-ins which should be completed in the next couple weeks.

JONES MIDDLE SCHOOL - ADDITION AND RENOVATIONS (BG #21-202 / REH #129-121-B)

Ashley Construction has the project weathertight and is working on painting and finishes inside. The project should be completed in the next month or so with some things lingering into the warmer weather such as seeding and site work.

This project is in its final stages of completion. Closeout continues to be finalized with documentation being verified before turnover to the District for their use. Punchlist has taken place and the Architect is going to walk the entire job with Surfaces Central on Friday to identify various items which still need to be addressed. The final application for payment will be presented upon completion, with the BG-4 Contract Closeout and BG-5 Project Closeout to follow.

RYLE HIGH SCHOOL - PHASE 2 FLOORING UPGRADES (BG #23-271 / REH #129-922-A)
