Below I have prepared a brief scope of work and approximate budget to replace the specified roof elevation(s) at Radcliff Middle School. Please find the enclosed roof plan which denotes Roof Section 'A' and Roof Section 'B'.

SECTION 'A' Roof Replacement Scope of Work: (see enclosed roof plan)

- A. Tear-off existing single ply roofing system down to the light weight concrete deck. Repair any deteriorated or unsound deck as a unit cost 'add' to the contract.
- B. Nailed down a 28 lb trilaminate base sheet according to Factory Mutual guidelines.
- C. Install base layer of 1" polyisocyanurate insulation with a second layer of 1/2" wood fiber insulation. Adhere both layers in a full and continuous application of Type III asphalt. Stagger all joints as per NRCA,
- D. Construct a four (4) ply built-up roof system using Type IV fiberglass felts adhered in SEBS hot-melt adhesive. Shingle all roofing plies.
- E. All flashings and terminations will be installed as per manufacturer requirements.
- F. Fabricate and install new sheet metal components to include counterflashing, parapet wall coping cap and associated details.
- G. Properly flash all roof drains according to manufacturer requirements.
- H. Final protective surfacing will be a flood coat of cold applied adhesive with new clean gravel.
- I. Tremco will provide a twenty (20) year roof system warranty at the completion of the roof installation.

- C. Install base layer of 3" polyisocyanurate insulation with a second layer of 1/2" wood fiber insulation. Adhere both layers in a full and continuous application of type III asphalt. Stagger all joints as per NRCA requirements.
- D. Construct a four (4) ply built-up roof system using type IV fiberglass felts adhered in SEBS hot-melt modified asphalt. Shingle all roofing plies.
- E. All flashings and terminations will be installed as per manufacturer requirements.
- F. Fabricate and install new sheet metal components to include counterflashing, parapet wall coping cap and associated details.
- G. Properly flash all edges, terminations and equipment according to manufacturer requirements.
- H. Final protective surfacing will be a flood coat of cold applied adhesive with new clean gravel.
- I. Tremco will provide a twenty (20) year roof system warranty at the completion of the roof installation.
