Facilities, Transportation, and Safe Schools

Safety:

- Active Supervision (NIS) and Gatekeeper (all schools) training took place on February 15, 2023. We will continue to utilize the resources of the Kentucky Center for School Safety regarding future training that will be implemented districtwide and school specific. Mr. Watts and I met with Dan Orman from KCSS on February 16 to review the official reports from the December 6, 2022, safety assessments. Overall, the reports were positive and I am already addressing areas of mutual concern. Dan will be attending our March 8, 2023, working meeting to share a snapshot of the reports. Furthermore, we are scheduling the KCSS to attend our End of the Year Administrative Retreat to provide Threat Assessment training and guidance for our emergency response and reunification plans.
- Mobilcomm has been on-site for the week of February 13, to install the repeaters for our new radio system. I will be meeting with a representative from Mobilcomm on February 24, to receive our new radio and be trained on the radio functions.
- I have communicated to all principals the creation of a districtwide safety committee. The purpose is to form a sustainable process to hear from each school to address concerns, plan professional development, and to proactively prevent scenarios. Since the last board meeting, I have already met with the team from the high school and will meet with the NIS committee on February 23 and the NPS committee on March 1.
- Installed a new LifeVac Choking Rescue Device in the new NPS cafeteria.
- We are going to be doing a planned power outage at NIS over Spring Break to test the generator and address any issues that we may discover.
- (On-going) Based upon the KCSS safety assessment, we are getting a quote to add a camera in the Wildcat Sanctuary area of NIS. During the warmer months teachers utilize this area as an outdoor classroom.

- We have received occupancy of both the cafeteria and kitchen at NPS. Work is continuing and we are nearing the end of the project. We are waiting for the new roof top units for the cafeteria and gymnasium. We are expecting them to be craned into place during Spring Break

(there still may be a chance that we can do this on March 17). There will be additional meetings pertaining to the overall project and we will soon address any final punch list items.

- I met our architect and representatives from Comtek Flooring to walk the sites to prepare for the projects that will take place this Spring Break and over the summer.
- Phase 1 of the Athletic Complex is still on pace. We have removed all athletic equipment and anything of value from under the bleachers. Once abatement has occurred, we will continue removing copper and other fixtures.
- On February 6, 2023 we held a Zoom meeting to discuss moving forward with the culinary project at NHS. We reviewed the plans and requested an updated cost before moving forward. Once we have that information and a tentative schedule we will bring this information to the board.
- The steam boiler at the Welcome Center continues to be an on-going maintenance issue. We will continue to do our best to keep it operational however that is why one of our upcoming projects is the Welcome Center HVAC replacement.
- Current projects in early phases: NPS Roof, Athletic Complex, NHS Culinary Arts, and Welcome Center HVAC.

Transportation:

- On February 20, 2023 the new camera systems will be installed on the buses. I will keep the board informed of the effectiveness of using the video footage to address drivers running stop signs.
