Information/Review/Discussion Item:

Consider 2023-2024 School Calendar (2nd Reading – two readings required).

Applicable Statute or Regulation:

KRS 158.060, KRS 158.070, and 704 KAR 7:125 (board to adopt a school calendar for the upcoming school year on or before May 15).

Fiscal/Budgetary Impact:

Loss of funding is possible if legal standards are not met for attendance requirements.

History/Background:

The district calendar committee met on Tuesday, February 7 to discuss the 2023-2024 school calendar. Groups represented by the committee included principals, teachers, parents, community members, classified employees, and the board. The option presented is one that all committee members support.

Talking Points:

- First day for students is Wednesday, August 9
- The last scheduled day for students is Friday, May 7, 2024
- The calendar includes 170 student days. The length of each instructional day will be 6 hours and 15 minutes to meet the requirements of 170 days and 1,062 hours.
- No days will be banked.
- We will have 10 NTI days. All days missed that are not NTI days will be added to the end of the calendar.
- The calendar includes seven G or planning days for staff.
- 240-day employees would have two additional holidays on Tuesday, July 4, 2023 and Monday, May 27, 2024.
- The testing window for 2023-2024 is the last two weeks of school.

Approve 2023-2024 school calendar (1st Reading).
