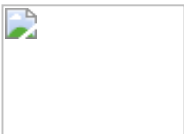

As a player who graduated in 1985, and as a father who watched his son , cousins , and nephews play for the Green Waves, I have a great interest in the future of our football program. As a local businessman, healthcare provider and farmer, I have an even greater interest in the well-being of our community and school as a whole.

The people of our community have been traveling to Hardin County and Elizabethtown to shop, play ball , and when we need to go to the hospital for 75 years or more. Today, almost all of our kids involved in recreational and AAU travel ball have their focus in Hardin County. We are used to traveling there and have entrenched rivalries.

I have thousands of memories of our rivalry with North Hardin and Central Hardin in football, and in all of the other sports. Let me illustrate a few that come to mind. As a junior in 1983, I remember playing North Hardin who had Neil Fatkin. He had a reputation that he could not be tackled. Before the game, he walked on his hands from the 50 yard line to the end zone with football pads on. ....,We were were intimidated before the game even started. Flash forward a few years and I see Blake Powers quarterbacking the Green waves against Andre Woodson for the Trojans. Just a few years later, they would be playing each other as quarterbacks for the Indiana University Hoosiers and the University of Kentucky Wildcats, respectively. Those games were high level intensity. There was not a place to be found in the stands.!!

When I think of Central Hardin, I note that they have placed a heavy focus on football over the past decade and a half. There was a time however when Meade beat them 10 years in a row.
