RE: Update Prime Date Report – Girls Basketball

To update you on the current status of the Prime Date report for the 2022-23 girls' basketball season, I am submitting a report of the twenty-eight (28) KHSAA member schools that were not in compliance with the Prime Date Policy at the end of the season. According to my reports submitted to the Board of Control from this school year 28 schools, thirteen (13) member schools were not compliant at all three checks throughout the season (first playing date, middle of the season, last playing date). Those 13 schools are as follows:
