01.1 Legal Status of the Board

HISTORY/BACKGROUND:

In April of 2022 Senate Bill 1 was signed into law shifting the determination of curriculum, textbooks, and instructional materials to the local superintendent. The district implemented a collaborative process to comply with the law and determine trends/needs for our students and staff. As a result of this thorough review, the need for comprehensive reading and math resources was identified as a priority. This plan was developed after the collaborative effort of teachers, principals, and district staff and with school choice. We believe implementing a high-quality standards-based curriculum, supporting teachers with high-quality comprehensive resources, and evidence-based practices will provide an equitable environment for all.
