## **SECOND ADDENDUM TO MEMORANDUM OF UNDERSTANDING**

This second addendum to the Memorandum of Understanding dated January 10, 2022, entered into the \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between TODD COUNTY BOARD OF EDUCATION (hereinafter called “District”) and the TODD COUNTY SHERIFF (hereinafter called “Sheriff”);

### **WITNESSETH:**

Whereas, the District and the Sheriff entered into a Memorandum of Understanding dated January 10, 2022; and,

Whereas, the District and the Sheriff entered into a First Addendum to that Memorandum of Understanding dated the 12th day of September, 2022;

Whereas, it is the desire of the Sheriff and the District to memorialize the current total annual compensation of the school resource officers assigned to North Todd Elementary School, South Todd Elementary School, and Todd County Central High School, based upon the annual pay increase of all county employees commencing January 1, 2023, in compliance with paragraph 3 of the First Addendum to the Memorandum of Understanding and to amend the number of SRO’s beginning July 1, 2023.

NOW, THEREFORE, it should be and is hereby agreed as follows:

1. From January 1, 2023 to June 30, 2023, the Sheriff shall furnish school resource officers for North Todd Elementary School, South Todd Elementary School, and Todd County Central High School.
2. From July 1, 2023 through December 31, 2023, the Sheriff shall furnish two school resource officers to the District whose school assignments shall be agreed upon by the District and the Sheriff.

3. The current total annual compensation for the school resource officers for North Todd Elementary School, South Todd Elementary School, and Todd County Central High School shall be as follows:
  - a. North Todd Elementary School: \$56,776.78
  - b. South Todd Elementary School: \$56,776.78
  - c. Todd County Central High School: \$46,737.60
4. The total annual compensation for the school resource officers described in paragraph 3 above, shall beginning at July 1, 2023, be reduced to reflect the modifications to the First Addendum to Memorandum of Understanding dated the 12<sup>th</sup> day of September, 2022, eliminating one SRO position.
5. In each and every other respect, the Memorandum of Understanding dated January 10, 2022, as modified by First Addendum, dated the 12th day of September, 2022, remains in full force and effect and its terms are incorporated herein by reference as except as modified herein.
