### **MUNICIPAL ORDER 14-2023**

A MUNICIPAL ORDER AUTHORIZING THE MAYOR TO EXECUTE A DEED CONVEYING PROPERTY LOCATED AT 200 WILLIAMSBURG SQUARE TO REGIONAL WATER RESOURCE AGENCY (RWRA), ON WHICH RWRA HAS BUILT A PUBLICLY OWNED PUMP STATION FOR ITS OPERATIONS.

WHEREAS, in 1994, the City of Owensboro and Daviess County established Regional Water Resource Agency (RWRA) by Ordinance 48-94 as a regional comprehensive wastewater collection and treatment system within Daviess County; and

WHEREAS, Section 5 of Ordinance 48-94 directed that all existing assets, liabilities, easements, personnel, control, management, and authority of the defunct Owensboro Sewer Commission be transferred to, and become a part of RWRA; and

WHEREAS, some of these assets still remain in the name of the City of Owensboro and in the records of the Daviess County Property Valuation Administrator in the name of the City of Owensboro; and

WHEREAS, the City of Owensboro owns certain real property located at 200 Williamsburg Square in Owensboro, Daviess County, Kentucky, containing 0.029 acres, more or less, on which an RWRA pump station is located; and

**WHEREAS**, RWRA has requested that the City of Owensboro execute a deed of conveyance of the property located at 200 Williamsburg Square.

NOW, THEREFORE, BE IT ORDERED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

**Section 1.** That the Mayor be, and he hereby is, authorized and directed to execute a deed of conveyance to property located at 200 Williamsburg Square containing 0.029 acres, more or less. A copy of the deed is attached as Exhibit A.

**Section 2.** That the Mayor, City Manager and appropriate staff members are hereby authorized to execute any and all other agreements, plats, instruments or documents deemed necessary to the furtherance of the authority outlined herein.

A parcel of land located at 200 Williamsburg Square, in the City of Owensboro, Daviess County, Kentucky, and being described as follows:

**Beginning** at a P.K. nail in the sidewalk, said point being approximately 129.0 feet east of the east right-of-way of Veach Road, said point also being in the south line of Owensboro Christian Church (Plat Book 38, Page 101; **thence** with said Church and Williamsburg Square **North 79 degrees 08 minutes 20 seconds East, 55.11 feet** 

to a ½ inch rebar set with cap stamped "M.R. P.L.S. 3514", corner to the City of Owensboro (Plat Book 40, Page 101); thence with a new line of the City of Owensboro, South 10 degrees 29 minutes 18 seconds East, 21.83 feet, to a ½ inch rebar set with cap stamped "M.R.
