Student 1:1 Device Refresh Proposal Summary Sheet

Background Information: Our 1:1 Device Program uses iPads for students in grades K-5 and Macbook Airs in grades 6-12. The last payment of the lease for the current devices was made earlier this year. While on the one hand this means that the district owns those devices entirely now, it also means that all student devices, with the exception of the 6th grade Macbook Airs, have reached the end of their AppleCare warranty coverage. While the devices have useful life left, it is no longer cost-effective to repair them, as the standard out-of-warranty repair cost exceeds half the purchase cost of a new device.

It is the Tech Department's recommendation to follow previous practice and enter into a new device lease to maintain AppleCare coverage on all student devices. Bids for auction/buyback of the retired devices would be obtained and the proceeds used to offset or possibly cover the first lease payment on the new agreement. Damaged or inoperable devices bring little to no resale value, so the return on a trade-in is at a high for the district now.

Proposed Lease Details: We are requesting board approval to proceed with a 4 year lease that includes 700 Macbook Air laptops, 650 iPads, a protective case for each device (which usually need to be replaced at the district's cost after a couple of years) and 4 years of AppleCare+ for Schools warranty coverage. The total price of this lease is \$1,004,932.50. Apple has offered 1.9% financing, which would make each lease payment \$258,369.96. For reference, the 4 year lease which just ended's payments were \$281,270.00. That lease included staff devices, but also was during a time of 0% financing being offered, but is still in line with what we have been budgeting for annually.

Additional Benefits: The new terms of the AppleCare+ for Schools have lowered the basic accidental charge per incident from \$100 to \$0. Liquid and intentional or extreme damage do still incur_a fee. AppleCare+ does increase the initial cost of the devices, and in order to help build a sense of ownership and responsibility in our students, we think a lower repair fee or service hour agreement is still in order, but should be less of a burden on families to pay while still offsetting the additional upfront cost of the warranty coverage provided by the district. Potential changes to our device agreements are in the planning stages.

Next Steps: If the board approves moving forward with this lease plan, we would begin the required state approval process for any leases over \$100,000 and prepare a waiver application needed to be able to purchase the Macbook airs in alignment with state contract procurement rules. We would like to move forward as soon as possible so that the we could take delivery of the devices as close to July 1 as possible in order to prepare them for the upcoming school year. The approval process can take some time to get through and although we do not expect supply-chain issues at this time, we are wary of that as well and need as much lead-time as we can get. After state approval, the board would then formally agree to the lease at a later meeting.
