COMMUNICATIONS

Audience Comments

Ms. Sue Floyd spoke about the rough conditions of the weight room at North Bullitt High School and asked the board members to take a look at the pictures taken two days ago and fix this as soon as possible.

Superintendent's Report

Dr. Bacon responded to Ms. Floyd's issue with the NBHS weight room. Although new facilities are coming, the district can take a look at that facility and clean it up to get through the next two years. He will work with the athletic director and Maintenance Department in the meantime to address that issue.

Dr. Bacon also mentioned that the current question on parents' and students' minds is when will a graduation date be set. This is the rough time of the school year to determine that although winter hasn't been as bad as previous years. Jefferson County Public Schools still has to determine their graduation date, as they have priority scheduling of the space at the Kentucky Fair and Exposition Center. Currently, JCPS and BCPS have the same last day for students, May 26th. If JCPS has graduation that Memorial Day weekend, BCPS may need to wait until the following weekend.

Other Items from the Board

Linda Belcher asked if North Bullitt was first on the list to start construction of the stadiums. Dr. Bacon responded that all stadiums would start at the same time, along with renovations to Bernheim Middle and the extra Bullitt East projects involving the previous Old Mill Elementary School building.

Darrell Coleman asked who is responsible for the North Bullitt High School weight room. Dr. Bacon said the custodian and athletic director, as well as the Maintenance Department. They need to figure out what can be fixed now. Facilities Director Tony Roth said he will go to North Bullitt tomorrow to begin that process and communicate back to Dr. Bacon a plan of action. He will check into removing

the insulation, evaluate the mold, and investigate options of providing water for drinking and handwashing. Dr. Bacon will communicate that plan of action to the board.

Construction Items

1. Use of Contingency Funds Request - OMES Furniture

Requested was use of contingency funds to purchase additional furniture for rooms 100b, 200b, and 300b. The cost of the furniture is \$23,598.00. This will change the contingency fund balance from \$423,490.21 to \$399,892.21.

2. <u>Use of Contingency Funds Request - OMES Door Technology</u>

Requested was use of contingency funds to purchase technology for door hardware due to changes in SB1. The total cost is \$22,533.63. This changes the Contingency balance from \$399,892.21 to \$377,358.58.

3. OMES Change Orders #26, #27, & #28

The following are Change Orders for the New Old Mill Elementary School:

- #26 Sound Insulation at Administration Offices \$2,357.50
- #27 Electrical Work for Domestic Booster Pump \$3,409.89
- #28 Wall-Mounted Electric Heater in Playground Restroom \$5,539.25

These change orders will change the contingency balance from \$377,358.58 to \$366,051.94.

4. Use of Contingency Funds Request - OMES Additional Door Hardware

Requested was use of Contingency Funds to purchase additional door hardware to come into compliance with SB1. The amount of the hardware is \$10,222.39. This changes the contingency balance from \$366,051.94 to \$355,829.55.

5. Bernheim Middle School Design Development / BG-2 & BG-3

Presented for the Board's approval were the Design Development Drawings for Bernheim Middle School and the supporting BG-2 and BG-3 Documents for the renovation project.

6. <u>Permission to Accept Bid – H.S. Football Stadiums General Construction Contract – Calhoun Construction</u>

A bid opening was held on February 15th, 2023, with one bid submitted for the general construction of the high school football stadiums. The bid had all the required documents. Calhoun Construction submitted a base bid of \$11,600,000.00. There were also three alternates on this project that total \$673,000.00. Approval was requested of the base bid amount and enter into contract with Calhoun

Construction in the amount of \$11,600,000.00 and to accept the three alternates as indicated in the amount of \$673,000.00 for a total construction amount of \$12,273,000.00.

7. Revised BG-1, BG 23-157 – Three H.S. Football Stadiums / BEHS Projects

Presented was the revised BG-1 (BG-23-157) for the Three High School Football Stadium Projects, along with the installation of an eight (8) lane track, tennis courts, and rear bus exit at Bullitt East High School. The total estimated cost for this project is \$12,273,000.00. KDE requires a minimum of 5% contingency.

8. Football Stadiums - Cooperative Purchase Contracts & DPO

Provided were signed documents to the agreement the Board approved at the special meeting on February 1st, 2023, in an effort to secure bleachers, press boxes, etc. from Toadvine Enterprises for the football stadiums at each of the high schools. By using Toadvine, an approved vendor on the state's list, this will start the project 3-4 weeks early in an effort to finish seating by the start of the fall season. Also presented is the KDE DPO with Vine & Branch (Toadvine Enterprises).

2. Entry of the Employment Records in the Minutes of Record

Employment records for both the certified and classified personnel for the period of **January 2023** through **February 2023** were submitted for the Board's information and inclusion in the minutes of this meeting.

Contracts

1. Cintas Uniform Contract

This contract with Cintas is for uniforms in the Maintenance Department, using the OMNIA partnership, to save the district \$81.99 per month. This contract is for two years with an option for a third year.

2. BC Technologies for NBHS

North Bullitt High School Athletics requested approval of the contract with BC Technologies, doing business as FinalForms, to keep track of and update all required forms required for student athletes to participate in sports. This will be paid by Athletic Activity Funds. The contract had been reviewed by Dinsmore & Shohl, LLP.

3. John E. Reid & Associates, Inc. Letter of Agreement

This agreement with John E. Reid & Associates, Inc. provides training for school and district-level administrators of techniques in interviewing and investigating incidents involving both students and staff. The cost of this four-hour training is \$2,500 and is funded by the student learning budget.

4. Mathnasium Tutoring Contract

The Department of Special Education requested permission to utilize Mathnasium for tutoring services needed to fulfill compensatory education requirements for an elementary age student. The provision for utilizing this outside agency to access their educational specialists for tutoring purposes was agreed upon by an ARC decision based on the student's limited academic and behavioral stamina to attend any potential before or after school opportunities provided by district personnel. The anticipated cost for tutoring is \$3,200. Funding will come from the Department of Special Education's General Budget allotment.

5. Bullitt County Road Department - EMS Bus Entry Lane & Parking Lot Extension

Requested was approval to work cooperatively with the Bullitt County Road Department to develop a separate bus entry off Ellis Cook Road onto the Eastside Middle School campus to add an additional entry lane off Highway 44 and extend the drive and parking lot. This project will result in the following:

- 1. KDE Best Practice is to have separate bus/car entrances.
- 2. Adding the extra land will create two entry lanes and allow the left run lane exit road to be used for that purpose.
- 3. Extending the entry drive 600 feet will allow for two entry lanes totaling 1,200 feet and allow an additional 60 cars in pickup lines to be off Highway 44.
- 4. Creating the extra parking lot will allow an additional 60-70 parking spots for school events.

The Fiscal Court of Bullitt County is willing to provide the labor and machinery needed to create the roads and lot at no cost. The District will need to pay for rock (estimated 3,000 tons at \$11.00 per ton = \$33,000) and asphalt (estimated 1,300 tons at \$55.00 per ton = \$71,500). Additionally, the District would need to deed 12 feet of property on Ellis Cook for the widening of that road to accommodate two-way traffic.

6. GBCYFL MOA

Presented for review and approval was a Memorandum of Facilities Use Agreement with the Greater Bullitt County Youth Football League (GBCYFL). The MOA was created by Emily Vessels and Eric Farris.

7. Adidas Agreement w/BEHS

Presented was an agreement with Adidas with Bullitt East High School for the 2023-2024 school year. It has been referred to Eric Farris for review.

8. Bluegrass Behavioral Health Services MOA

A spreadsheet was provided with that information for approval of curriculum and/or instructional resources for these schools: BLMS, NBHS, MES, OMES, OES, BEHS, BCHS, NES, and RES.

2023-2024 Tuition Rates

Requested was approval of non-resident tuition rates and temporary non-resident tuition rates for the 2023-2024 school year as required under Policy 09.124 - Tuition. Presented was the Tuition Calculation Worksheet that was created by the Finance Department. After further review and consultation with Finance Director Lisa Lewis, it was recommended to have one set tuition rate for all Non-Resident Tuition.

- The recommended 2023-2024 tuition rates for non-resident students and temporary non-resident students is \$2,483.07.
- Families that move into the district will be reimbursed the unused portion of their tuition.
- The district will receive \$4,100 from KDE for all students enrolled in BCPS, to include nonresident students.
- Non-Resident, Full-Time District Employees shall not pay tuition to transfer their child to Bullitt County Public Schools.

According to Tuition Procedure 09.124 AP.1, tuition shall be paid in full prior to school starting for non-resident students that are not children of employees.
