The top changes:

- 1. Updated the warranty verbiage. Currently the date is August, but because of the delays in the supply chain, it will start or in August or 10 days after the N inspection. Whichever is later.
- 2. Removed Kentucky specific tests for the burn test. Everything but the number of feet matched the nationally recognized test.
- Added Interior lamps shall turn on when emergency exits are opened, and the key is in the ignition. The emergency alarm is also required to turn on when the emergency exits are open. This will allow the driver to see what is happening and illuminate the bus in an emergency.
- 4. Added "Use Handrail" and "No Trespassing" to the stepwells.
- 5. Added the allowance of an OEM cupholder due to extreme heat conditions in the summer and fall.
- 6. Removed the required location for a lift to allow additional seat configurations that can allow more students on the bus.
- 7. Re-added the "lollipop" lights as standard vs optional at the committees request.
