**Addendum to Agreement**

Reference is made to the agreement to "Results Planning Process Agreement" by and between the undersigned parties, Partners for Rural Impact, Inc ("PRI") and Floyd County Board of Education ("School District"), said agreement effective 9/26/2022, and executed PRI on 8/25/2022, and by Floyd County Board of Education on 8/22/2022.

WHEREAS, that for mutual benefit and agreed consideration, PRI and School District made the following revisions a part of said contract as if contained therein:

WHEREAS, PRI is the administrator of a GEAR UP (Gaining Early Awareness and Readiness for Undergraduate Programs) ("GEAR UP") Partnership Grant GEAR UP EastKY Award number P334A220102 ("Grant"), awarded to the Appalachian Educational Service Agency ("AESAs") from the U. S. Department of Education with the CFDA #84.334(A) for the purpose of implementing programming for early college preparation and awareness activities for low-income students in accordance with the GEAR UP Program authorized under 20 U.S.C. 1070a-21 and 2 CFR Part 200 and other pertinent federal statutes and regulations (collectively, the "GEAR UP Program Regulations"). The Performance and Budget period applicable to Gear Up funds is 9/26/2022-9/25/2023.
