HISTORY/BACKGROUND:

Simon Kenton High School is requesting the board to consider allowing us to renew our contract with Swank Motion Pictures Inc. for the Swank K-12 Streaming product. The Swank company does not create agreements for less than 12 months, so this issue paper is requesting the purchase of the sales contract from 05/2/2023-06/30/2023 to complete our current school year payable as soon after the board approves this purchase as well as the purchase for the 2023-2024 school year. The Swank K-12 Streaming product is a comprehensive video collection of both feature films as well as educational documentaries that are applicable to all departments within our school. This product will allow our students to view assigned videos either in class or remotely thru the website while allowing the school to stay in compliance with applicable copyright laws.
