HISTORY/BACKGROUND:

This is the forteenth (14th) change order for the Scott High School Phase V, Taylor Mill Site Circulation, and Woodland Middle School Addition and Renovation Project associated with Morel Construction. The original contract was \$31,401,986.00. This change order for an additional \$27,294.00 with previous change orders of \$588,729.79 makes the new contract sum \$32,018,009.79.

Item No 1: Furnish and install structural steel, roof decking, and masonry lintels associated with main gym duct routing. ADD: \$ 13,500.00

Item No 2: Furnish and install boiler exhaust roof flashing at Woodland Middle School. ADD: \$ 2,417.00

Item No 3: Furnish and install saddles and tapered insulation at 3 ponding water locations at the existing roof.

ADD: \$ 11,377.00

TOTAL ADD: \$ 27,294.00

Furnish and install saddles and tapered insulation at 3 ponding water locations at the existing roof. Requested by Contractor. Cost Benefit to Owner: Required for re-roof warranty to address insufficient slope at multiple locations in existing roof. ADD: \$11,377.00


