Mr. Watts recognized Jennifer Steidel-Jones upon retiring from Newport effective April 30, 2023. Jennifer has been in education for 30+ years.

The board took at 10-minute break to welcome this evening's guests.

COMMENTS FROM THE AUDIENCE

Ms. Karen Strayer addressed the board regarding SB 5. This bill deems material, events, or programs that are obscene, harmful to minors, or contains obscene imagery representing minors as educationally unsuitable; the bill will require districts to remove student access to materials, programs, or events deemed educationally unsuitable; modify the complaint and appeals timeline; provide that willful violation be basis for employee disciplinary action; require local boards of education to adopt policies to prevent educationally unsuitable material from being introduced into the school library or being on school property; require the Kentucky Department of Education to provide model policies to implement the provisions; and make technical corrections to conform.

Mirna Eads addressed the board on book challenges. Mr. Watts informed her that a complaint to the district would need to come from a Newport resident. She inquired about new policies regarding SB 5 and it was explained that KSBA will be updating all policies and procedures by the end of the May for local boards of education to approve, amend, or adopt as written. She shared explicit excerpts from current library books that she and many others feel is unsuitable for school-aged children. Ms. Malone said the high school has a procedure in place right now for checking out material that is not age appropriate, but will review all policies & procedures when received to make sure the district is in compliance.

STUDENT LEARNING AND SUPPORT SERVICES

Mr. Watts updated the board on the following legislative bills:

- HB 5 This bill allows an exemption of the property tax on distilled spirits stored or aging in barrels located in a bonded warehouse or premises; this may have a minor effect on the district since New Riff is located in Newport.
- HB 32 This bill allows for the hiring of classified personnel without a high school diploma or equivalent if the district provides the employee the opportunity to obtain a high school equivalency diploma at no cost to the employee.
- 3. SB 5 This bill deems material, events, or programs that are obscene, harmful to minors, or contains obscene imagery representing minors as educationally unsuitable; the bill will require districts to remove student access to materials, programs, or events deemed educationally unsuitable; the bill modifies the

complaint and appeals timeline; provide that willful violation be basis for employee disciplinary action; requires local boards of education to adopt policies to prevent educationally unsuitable material from being introduced into the school library or being on school property; and requires the Kentucky Department of Education to provide model policies to implement the provisions; make technical corrections to conform.

- 4. SB 25 relates to postsecondary readiness indicators for demonstrating career readiness. This bill provided clean-up language to clarify that earning a minimum of three (3) hours of dual credit or a minimum of three (3) hours of postsecondary articulated credit can be achieved by: 1. Successfully completing a career and technical education or general education dual credit course which is equivalent to a minimum of three (3) hours of college credit; or 2. Passing a CTE End-of-Program Assessment associated with an articulation agreement.
- SB 150 Section 1 Schools and districts should be prepared to provide comprehensive notice of the health services and mental health services available to students upon enrollment. Additionally, schools should develop procedures for notifying families of referrals to health services or mental health services by a teacher.

Section 2 - The selection and usage of curriculum or programs on human sexuality or sexually transmitted diseases.

Section 3 - Requires local boards of education to adopt policies to "not allow students to use restrooms, locker rooms, or shower rooms that are reserved for students of a different biological sex".

- Mr. Watts reported they are finishing up walk-throughs for this school year,
- Leaders will be presenting a lot of data at the May 10th work session.
- NWEA has requested an amendment to the contract with the district. They were unable to accomplish everything set out for year one so they are requesting an amendment to carry those in to year two.
- The Apple Lease was discussed previously at a meeting. This is the next step in the approval process for KDE so laptops can be ordered in a timely manner.
- The End of Year Celebration luncheon is scheduled for May 30 at 11:30. The event will be held at the high school.

Darla Payne presented the curriculum department report. Ms. Sheffel asked about the dates for state testing. May 8-25 is this year's testing window.

Ms. Malone asked if there would be pre and post assessments for summer school this year. Ms. Payne confirmed everything will be the same as the past couple of years.

Ms. Stewart presented the DPP and Student Services update. There were no questions. She also provided a copy of the 22/23 Phase Four Continuation of Learning Plan for Districts.

Mr. Maines presented the facilities, transportation and safe schools update. He shared a PPT presentation on the current safety measures utilized throughout the district. Mr. Maines also shared additional security measures he is looking in to; i.e. security film on windows to give school personnel more time to seek shelter from an intruder and allowing first responders more time to get to the scene. Mr. Maines showed a short video on how the use of this film on windows does buy time for school officials in these instances. Our current PA system has the capability of creating alarm sounds in the event of an emergency. He is currently investigating how we can use this technology to sound an alarm when a lock-down is necessary.

Ms. Swanson presented her update on special education services. Special education teachers will begin using TouchMath this fall. This is standards-based and aligned to current curriculum standards with a concentration of focus, coherence, application, and modeling within developmentally appropriate learning paths. The multisensory approach makes critical math concepts such as counting, working memory, and recognizing patterns appealing to young students. The program was funded with ESSER money.

Ms. Rizzo, Director of Food Service, presented her report. There were no questions.
