

## **Equipment Grants**

As the sport's National Governing Body, and Official Youth Football Development Partner of the NFL, the NFL Players Association, and all 32 NFL teams, USA Football is committed to enhancing the football experience for all at the youth and amateur levels through our Equipment Grants Program.

USA Football enables eligible youth football organizations and school-sponsored football programs to apply for the following grants:

- Youth Football Equipment Grant (retail value approximately \$1,000)
- High School Equipment Grant (retail value approximately \$1,500)

All applications must follow the attached format and include all specified information in the designated order. Incomplete applications will be returned and will not be eligible for consideration.

USA Football strongly prefers that applications be submitted online via <a href="www.usafootball.com">www.usafootball.com</a>. Grant applications submitted by mail must be postmarked by **June 4, 2010.** Applications received by fax will not be eligible.

### Youth Football Equipment Grant (retail value approximately \$1,000)

#### Criteria:

- · Organization's contribution to its community
- Organization's financial need

### Eligibility Requirements:

- 501 (c)(3) not profit youth football organization
- · Operate on the local or regional level
- · Application must be submitted by board member if the applicant is a non-profit organization

NOTE: Members of former NFL Youth Football Fund partner organizations are now eligible the USA Football Equipment Grant. Those organizations are: Amateur Athletic Union; American Youth Football; Boys & Girls Clubs of America; Jewish Community Centers Association; National Police Athletic League; National Recreation & Park Association; Pop Warner; YMCA of the USA.

1. Why does your organization deserve a grant?

I think our organization/program is deserving of a grant for several reasons. First being that the program has struggled in terms of wins/loses which has in turn reduced the total turn out through the years. We are trying to change things and turn the program around by hiring a completely new staff and get kids back playing football. Next Todd County is a very rural area with 20% of our students being minorities. Money is extremely tight therefore we do not have the money to purchase new equipment, upgrade equipment or even to fix/repair old completely. Our county receives Title I funding, however: our board chooses to have all allocations issued only to our elementary schools.

2. What is the biggest challenge you face as a high school football coach?

The biggest challenge as a high school coach is raising money year in and year out consistently to keep up with the increase cost of running a program, reconditioning equipment, replacing old equipment, etc. Many people/business struggle to donate year in year out with the economic times we are currently facing. As previously mentioned, our county receives Title I funding, however; our board chooses to have all allocations issued only to our elementary schools.
