As people of Kentucky, we are committed to building a vibrant <u>state-wide assessment and accountability ecosystem</u> through inclusive co-design processes that helps to <u>create an</u> educational culture that:

# [More Humanistic Flavor]

- 1. rejects a "shame-and-blame" mentality and reimagines what matters in education.
- 2. rejects the historical "factory model" of education and embraces learners holistically.
- 3. encourages vulnerability that allows all stakeholders to view themselves as learners.
- 4. foregrounds mutual respect, authentic trust, and professional integrity
- 5. nurtures a sense of shared responsibility for the success of all learners.
- 6. addresses the academic, behavioral, and social-emotional needs of all learners.
- 7. incentivizes and values vibrant learning experiences centered around deeper learning.
- 8. puts marginalized and vulnerable learners at the center of efforts.
- 9. allows all learners to be seen, valued, and represented in authentic and meaningful ways.
- 10. makes room for the unique passions of learners from all cultures and backgrounds.
- 11. allows all stakeholders to lift up inspiring educational efforts without corrupting them.

- 12. encourages the identification and resolution of systemic sources of inequities.
- 13. views all stakeholders as learners who can contribute to making the system successful.
- 14. supports individual fulfillment and collective prosperity for all stakeholders.
- 15. incentivizes learners to do their best and yields authentic pictures of ability and potential.

# [More Rational Flavor]

- 16. encourages the development of complex competencies and skills that matter to learners.
- 17. encourages learners to explore diverse pathways to postsecondary life.
- 18. builds on the professionalism of teachers and supports them in their own learning journey.
- 19. incentivizes, supports, and builds on local efforts for continuous school improvement.
- 20. is responsive to the needs of the community and leverages the support of its members.
- 21. encourages the consideration of rich and diverse data to inform learning processes.
- 22. minimizes unintended consequences from system implementation across communities.
- 23. eliminates stakeholders' desire to game-the-system and undermine good intentions.
- 24. is sustainable without the constant need for heroic actions by heroic people.
- 25. leverages all available flexibility afforded by current federal regulation for its mission.
- 26. embraces diverse and meaningful conceptualizations of technical quality. provides all stakeholders with a coherent and comprehensive picture of learners.
