

AMENDMENT TO MEMORANDUM OF AGREEMENT AMONG JEFFERSON COUNTY PUBLIC SCHOOLS, 3DE KENTUCKY SCHOOLS, LLC and JUNIOR ACHIEVEMENT OF KENTUCIANA, Inc.

Revisions to Schedule 2.14 (Attachment A)

This First Amendment to the Memorandum of Agreement ("Amendment") is entered into by and among Jefferson County Public Schools ("JCPS"); 3DE Kentucky Schools, LLC, ("3DE"); and Junior Achievement of Kentuckiana ("JA of Kentuckiana") as of April 15, 2023. JCPS, 3DE, and JA of Kentuckiana shall collectively be referred to herein as the "Parties" and each may be individually referred to as a "Party".

- A. JCPS, 3DE, and JA of Kentuckiana entered into that certain Memorandum of Agreement dated November 13, 2019 (five-year renewal) (the "Agreement"), pursuant to which, among other terms, agreements and provisions, the Parties agreed to establish collaborative procedures between JCPS and 3DE to begin the implementation of 3DE at Valley High School and 3DE at The Academy @ Shawnee (2021-2022 school year launch).
- B. The Parties desire to update the specific data elements JCPS will share with 3DE as part of their ongoing evaluation of 3DE's Model, in order to make necessary adjustments to the program and to maximize 3DE progress and outcomes for students, teachers, the implementing schools and the school district.

NOW, THEREFORE, in consideration of the mutual promises and premises made herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties have agreed and hereby agree to this First Amendment as follows:

- 1) Paragraph 1.6 Confidentiality is hereby deleted in its entirety.
- 2) Paragraph 2.14 Permission and Access is hereby deleted in its entirety.
- 3) Paragraph 3.3 Program Evaluation and Assessment is hereby deleted in its entirety and replaced with the following: "Program implementation is to be monitored based upon criteria agreed upon by both JCPS and 3DE sixty to ninety (60-90) days prior to the end of each academic year to ensure appropriate program oversight. The parties agree to meet periodically and/or by request to discuss and collaborate to resolve any issues or concerns with 3DE's operations or implementation."
- Addendum Four is hereby removed in its entirety and replace with the attached Addendum Four Data MOA.

Addendum Four (Data MOA)

MEMORANDUM OF AGREEMENT Between Jefferson County Board of Education And 3DE Kentucky Schools, LLC

This Memorandum of Agreement (hereinafter "Agreement") is entered into between the Jefferson County Board of Education (hereinafter "JCPS"), a political subdivision of the Commonwealth of Kentucky, with its principal place of business at 3332 Newburg Road, Louisville, Kentucky 40218 and 3DE Kentucky Schools, LLC (hereinafter "3DE"), a Profit Organization located at 3565 Piedmont Rd NE, Building One, Suite 460, Atl, GA 30305.

WHEREAS 3DE will use secondary data to include in the 3DE Student Achievement Metrics reports. These reports include performance across key impact metrics and it also provides achievement and climate outcomes of 3DE schools. Information in these reports will enable the JCPS High School division to examine aggregated student and school performance of those students in the 3DE schools and students in the corresponding grade of 3DE implementation.

THEREFORE, in consideration of the terms, conditions, premises, and mutual agreements set forth herein, JCPS and 3DE agree as follows:

1. Duties of JCPS:

a. The JCPS Accountability, Research, and Systems Improvement (ARSI) department agrees to provide 3DE with the data elements requested and according to the schedule designated in Attachment A.

2. Duties of 3DE:

- a. Acknowledges that projects involving program evaluation, monitoring activities, or data collection or research of any kind, are subject to JCPS IRB review and approval as determined by the JCPS IRB to meet federal, State, and Board policies. In these cases, JCPS student or staff participation is voluntary. As a federally authorized Institutional Review Board (IRB), JCPS complies with the federal definition for research, which includes sharing of Personally Identifiable Information (PII) for the purpose of answering a question or evaluating activities for effectiveness beyond standard educational or operational procedures. Thus, all research, program evaluation and data collection activities must be approved by the JCPS IRB and shall not begin before approval is secured from the JCPS IRB.
- b. If the performance of this Agreement involves the transfer by JCPS to 3DE of any data regarding any student that is subject to the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. 1232g as amended, ("FERPA"), 3DE and JCPS must manage the data transfer in accordance with FERPA requirements, and 3DE agrees to the following conditions:

- i. If 3DE requests transfer of identifiable data by JCPS that is subject to JCPS IRB procedures, as determined by the JCPS IRB to meet federal, State, and Board policies, JCPS cannot transfer identifiable data to 3DE before the JCPS IRB-approved informed consent process has been executed. In this case, 3DE does not function as an exception under FERPA. 3DE is responsible for obtaining, and maintaining, signed consent after JCPS IRB approval. No data will be provided under this agreement without signed consent from the guardian for records requests involving students or from the JCPS employee or community member for records requests involving adults. 3DE must deliver copies of the signed authorization to JCPS upon request.
- ii. If 3DE has been legally deemed a FERPA exception by JCPS in accordance with FERPA Exception Conditions, then 3DE shall:
 - (a) In all respects, comply with the provisions of FERPA, including any requirements of Chapter 99 of Title 34 of the Code of Federal Regulations and any other applicable state or federal law.
 - (b) Use any such data for no purpose other than to fulfill the purposes of this Agreement, and not share any such data with any person or entity other than 3DE and its employees, contractors, volunteers, and agents, without prior approval of JCPS. Disclosure shall be limited to only those employees, contractors, volunteers, or agents who are necessary for the fulfillment of this Agreement.
 - (c) Require all employees, contractors, volunteers, and agents of 3DE to comply with all applicable provisions of FERPA with respect to any such data. 3DE shall require and maintain confidentiality Agreements with each employee, contractor, volunteer, or agent with access to data pursuant to this Agreement.
 - (d) Maintain any such data in a secure environment, whether physical or electronic, and not copy, reproduce, or transmit any such data except as necessary to fulfill the purposes of this Agreement. 3DE shall notify JCPS within 24 hours in the event of any data breach or disclosure of data to any person or entity other than the parties listed in this agreement.
 - (e) Collect, store, and maintain data in a manner that does not permit the identification of an individual student by anyone other than employees, contractors, or agents of 3DE necessary for the fulfillment of this Agreement and having a legitimate interest related to the purposes of this Agreement in knowing such personal identification, and not disclose any such data in a manner that would permit the identification of an individual student in any form, including, but not limited to, published results of studies.

- c. Limit data requested from JCPS to the specific elements listed in Attachment A. If the data request is associated with an approved JCPS IRB application, then the data in Attachment A should match the JCPS IRB final approval letter data elements listed.
- d. Adhere to the reporting timeframes (e.g., quarters, semesters, years) service provider requested in Attachment A.
- e. Adhere to the timelines in Attachment A for when a service provider will provide JCPS with 3DE [lists of students, signed consent forms, etc]. Notify JCPS of unexpected changes in timelines as soon as possible and accept that changes may alter JCPS' capacity to provide requested data.
- f. If relevant, obtain signed non-disclosures (Attachment B) for each individual from 3DE responsible for evaluation and analysis activities who must access identifiable data referenced in Attachment A.
- g. Use reports produced for this project only for the purposes described above. The data and reporting shall not be used for personal or institutional gain or profit.
- h. To direct all communication and decisions regarding the evaluation, data collection, and analysis to the Accountability, Research, and Systems Improvement office.
- i. Acknowledges that JCPS retains the right to audit 3DE's compliance with this agreement.
- j. 3DE acknowledges that any violation of this Agreement and/or the provisions of FERPA or accompanying regulations related to the nondisclosure of protected student information constitutes just cause for JCPS to immediately terminate this Agreement pursuant to Article V of this Agreement.
- k. Not use the name or logo of JCPS or individual JCPS schools in printed materials, websites, videos or social media without prior approval from JCPS.
- Maintain an all-risk property and casualty insurance policy with respect to the facilities and a policy of commercial general liability in amounts no less than \$1,000,000/\$2,000,000 per policy and provide JCPS with a certificate of insurance upon request.
- m. Require all 3DE employees/volunteers/contractors performing services under this Agreement to have on file a Criminal Records Check, per Kentucky law and JCPS requirements, completed no more than five years ago. Employees/contractors convicted of any of the following, per JCPS Board Policy 03.6, shall not be considered:
 - i. Any conviction for sex-related offenses.
 - ii. Any conviction for offenses against minors.

- iii. Any conviction for felony offenses, except as provided below.
- iv. Any conviction for deadly weapon-related offenses.
- v. Any conviction for drug-related offenses, including felony drug offenses, within the past seven years.
- vi. Any conviction for violent, abusive, threatening or harassment related offenses.
- vii. Other convictions determined by the Superintendent/designee to bear a reasonable relationship to the ability to perform services under this Agreement.
- n. 3DE shall require all staff and volunteers performing services on JCPS school premises during JCPS school hours under this Agreement to submit per KRS 160.380 to a national and state criminal history background check by the Department of Kentucky State Police and the Federal Bureau of Investigation and have a letter, provided by the individual, from The Cabinet for Health and Family Services stating no findings of substantiated child abuse and neglect records maintained by the Cabinet for Health and Family Services.
- o. 3DE staff and volunteers will comply with all JCPS health safety guidelines including rules related to COVID-19 mitigation.
- p. To the extent that JCPS facilities are closed to students, those facilities will also be unavailable to 3DE. During any periods of the Non-Traditional Instruction (NTI) or remote learning, JCPS facilities will not be available to 3DE.

3. Mutual Duties:

- a. Each party shall not discriminate based on race, color, national origin, age, religion, marital or parental status, political affiliations or beliefs, sex, sexual orientation, gender identity, gender expression, veteran status, genetic information, disability, or limitations related to pregnancy, childbirth, or related medical conditions.
- b. Each party shall comply with all federal and state laws and regulations and all JCPS policies applicable to the provision of the services described in this Agreement, including without limitation the Federal Family Educational Rights and Privacy Act (FERPA), the Kentucky Educational Rights and Privacy Act (KFERPA), the federal Health Insurance Portability and Accountability Act (HIPAA) and JCPS policies and procedures for volunteers and visitors entering JCPS facilities.
- c. The respective administrative offices of JCPS and 3DE who have responsibility for the implementation of this Agreement shall meet periodically during the term of this Agreement to evaluate the program and discuss issues of mutual concern.

- 4. Term: This Agreement shall be effective commencing June 7, 2023 and shall terminate on June 7, 2025 The Agreement may be extended by mutual written agreement of JCPS and 3DE.
- 5. Termination: Either party may terminate this Agreement prior to the end of its term by giving sixty (60) days prior written notice to the other party. If JCPS terminates the Agreement, 3DE will be permitted in their discretion to continue to provide services during the period in which the sixty (60) day notice becomes effective. JCPS may terminate this agreement immediately in the event of a student health or safety concern or a breach of paragraph 2.j above. In the event of an immediate termination, 3DE shall not be permitted to continue to provide services after receipt of the notice of termination.
- 6. Amendment: This Agreement may be modified or amended only by a written agreement signed by JCPS and 3DE.
- 7. Independent Parties: JCPS and 3DE are independent parties, and neither shall be construed to be an agent or representative of the other, and therefore neither shall be liable for the acts or omissions of the other. Each party shall, however, be liable for any negligent or wrongful acts of its own employees, students and invitees.
- 8. Captions: Section titles or captions in this Agreement are inserted as a matter of convenience and reference, and in no way define, limit, extend, or describe the scope of this Agreement.
- Entire Agreement: This Agreement contains the entire agreement between JCPS and 3DE concerning the 3DE and supersedes all prior agreements, either written or oral, regarding the same subject matter.
- 10. Severability: If a court of competent jurisdiction holds any provision of this Agreement unenforceable, such provision shall be modified to the extent required to make it enforceable, consistent with the spirit and intent of this Agreement. If such a provision cannot be so modified, the provision shall be deemed separable from the remaining provisions of this Agreement and shall not affect any other provision.
- 11. Counterparts: This Agreement may be executed in counterparts, in which case each executed counterpart shall be deemed an original, and all executed counterparts shall constitute one and the same instrument.
- 12. Applicable Law: This Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Kentucky.

MEMORANDUM OF AGREEMENT AMONG JEFFERSON COUNTY PUBLIC SCHOOLS, 3DE KENTUCKY, LLC and JUNIOR ACHIEVEMENT OF KENTUCKIANA, Inc.

WITNESSETH:

This Memorandum of Agreement, this "Agreement," is made and entered into by Jefferson County Public Schools, a public school district serving Jefferson County, Kentucky, with its principal headquarters located in Louisville, Kentucky, hereinafter referred to as "JCPS," 3DE Kentucky, LLC ("3DE") and Junior Achievement of Kentuckiana, Inc., a Kentucky nonprofit corporation ("JA of Kentuckiana"). Capitalized terms used but not otherwise defined herein shall have the meanings set forth on the attached Schedule A.

WHEREAS 3DE, directly or through 3DE National, LLC ("3DE National") or its affiliates, has developed, and continues to develop, an educational model that is relevant, experiential and authentically connected to real-world complexities, including a turnkey framework of education programs that bring real-world connectivity across core academic subjects using case methodology and linking standards-based and project-based education (the "3DE Model");

WHEREAS JA of Kentuckiana is a nonprofit organization, based in Louisville, Kentucky, that provides Junior Achievement programs to K-12 students throughout the region of Greater Louisville in collaboration with local school districts, including JCPS;

WHEREAS, JCPS seeks to implement the 3DE Model, at selected high schools in JCPS as may be agreed with 3DE (the "JCPS 3DE Schools");

WHEREAS, JCPS has actively collaborated with JA of Kentuckiana and 3DE to plan for strategic alignment;

WHEREAS, this Agreement seeks to establish and sustain collaborative procedures between JCPS, 3DE and JA of Kentuckiana to ensure a productive arrangement for design and implementation of the 3DE Model at selected high schools in JCPS per the attached addendum; and

WHEREAS, this Agreement represents the entire agreement between JCPS, 3DE, and JA of Kentuckiana;

NOW THEREFORE, the parties do agree as follows:

Section 1. Implementation by 3DE

1.1. Educational Personnel and Assistant Principal Training, Support, and Professional Development. 3DE will be responsible for the design and delivery of ongoing and periodic specialized training, support, and professional development offerings for 3DE educational personnel and the 3DE assistant principal. These offerings will be designed to

provide interdisciplinary planning support; coaching; credentialing and leadership opportunities; connectivity to the 3DE network of teacher, business, and community partners; industry exposure; and case methodology content support to the 3DE educational personnel as well as onboarding for the 3DE Assistant Principal and educational personnel.

- 1.2. Case Methodology Framework, Case Design, and Curriculum Enhancements. 3DE has created, and will create in connection with this Agreement, certain 3DE Programs and 3DE Materials, which include curriculum enhancement materials, such as case-based learning experiences using case design expertise including banks of lessons and activities to tie project-based and standards-based education. Such 3DE Programs and 3DE Materials will be used to ensure that all JCPS courses offered through JCPS 3DE Schools will be infused with 3DE interdisciplinary case methodology framework. Additional curriculum enhancements, such as entrepreneurial content and integrated financial literacy assets, will also be provided by 3DE. Pursuant to this Agreement, 3DE and JCPS intend to utilize such 3DE Programs and 3DE Materials, including adaptions and derivatives thereof, to create certain Work Product (as defined herein) consisting of specific programs and materials for use in connection with the establishment, operation and marketing of the JCPS 3DE Schools. As more specifically set forth in sections 4.6 and 4.8 of this Agreement, such Work Product will be owned by 3DE, and JCPS will license 3DE to use certain JCPS Properties in connection with the development and use of such Work Product hereunder. JCPS 3DE Schools will at all times remain under the control and management of the Jefferson County Board of Education and as such all decisions related to content and the direct instruction of students will be made by the 3DE educational personnel hired by JCPS, subject to the terms and conditions of this Agreement that pertain to content use and ownership. Materials delivered by 3DE will be adjusted as necessary by the 3DE educational personnel (subject to the ownership by 3DE of the 3DE Properties and any and all derivatives and modifications thereof, as more specifically set forth in this Agreement) to ensure compliance with all Jefferson County Board of Education and Kentucky Department of Education regulations, rules, policies and procedures, including ensuring compliance with the implementation of special education services.
- 1.3. **On-Site Personnel.** 3DE will hire, with JCPS input in accordance with Addendum Two, at least two full time personnel to serve as the Director-3DE and the Partnership Manager-3DE. The Director-3DE will work hand—in-hand with the school district assistant principal on all objectives, including the execution of the 3DE Model for the ultimate support and benefit of the students. The Partnership Manager-3DE will coordinate engagement activities with business partners. The Director-3DE and the Partnership Manager-3DE positions will be filled by 3DE personnel and will be paid for with 3DE funds. If JCPS believes the Director-3DE and the Partnership Manager-3DE to be ineffective, unsatisfactory, or out of compliance with any provision of this Agreement, JCPS will notify 3DE, identifying such conduct and providing support as necessary in writing. 3DE will promptly address the performance or conduct of the Director-3DE and the Partnership Manager-3DE in accordance with 3DE policies. 3DE and JCPS will continue to evaluate personnel needs in future years and make appropriate adjustments to positions as needed.

- 1.4. Activation of Business Partners. 3DE and JA of Kentuckiana will develop and maintain relationships and partnerships with local, state, and national businesses to enrich and expand 3DE's offerings and integration of industries, professionals, and post-secondary exploration into students' four-year high school experience including authentic career-readiness experiences and interaction with volunteers such as classroom advisors and coaches, and to supply other benefits, such as content support and guest speaker events, for each JCPS 3DE School and/or its student population. 3DE will train and vet all volunteers, as well as coordinate visits, contact, and activities between the volunteers and students.
- 1.5. **Student Safety.** 3DE will comply with all applicable state and federal laws, State Board of Education rules, and JCPS policies and procedures related to student health and safety, in accordance with guidance and training provided by JCPS. JCPS will issue written instructions to 3DE directing 3DE on compliance with such laws, policies and procedures and will additionally provide related training to 3DE directors, employees, volunteers, and agents as necessary. 3DE acknowledges that JCPS may screen in a timely manner all 3DE employees, volunteers, or other agents of 3DE, through JCPS systems and at JCPS's own cost, that come into contact with students of JCPS 3DE Schools to ensure student safety. The screening may include background checks, review of resume/credentials, and may include participation in interviews and/or hiring prior to assignment to 3DE.
- 1.6. Confidentiality. JCPS and 3DE acknowledge that its employees, agents, or representatives, may during the term of this Agreement, be exposed to or acquire information that is proprietary to or confidential to the parties or its affiliated companies or its clients or students. The parties will hold such information in strict confidence and represent and warrant that its employees, agents, or representatives will hold such information in strict confidence and not disclose such information to third parties, except to the extent required by law. To this end, the parties will advise each of its employees, agents, and representatives to keep such information confidential. The parties agree to comply with all applicable privacy laws and regulations, including with the Family Educational Rights and Privacy Act ("FERPA"), 20 U.S.C. § 1232g and the Protection of Pupil Rights Amendment ("PPRA"), 20 U.S.C. § 1232h.

JCPS will provide 3DE with reasonable access to the student body for surveys as part of the program assessment at times deemed acceptable by the Principal and JCPS, if any. All surveys will be in compliance with JCPS Policy and Procedure ICC and will be preapproved by JCPS prior to administration. All surveys will be anonymous unless written consent by surveyed parties of legal age of consent or their parents or legal guardians is received by JCPS. No survey will address any protected areas as defined in the PPRA, 20 U.S.C. § 1232h.

3DE is deemed to be a school official within the meaning of FERPA, 20 U.S.C. § 1232g, and the regulations promulgated thereunder, for purposes of the services provided under this Agreement. 3DE will be under the direct control of the school with respect to the use and maintenance of personally identifiable information and education records, as those terms are defined by FERPA, and use personally identifiable information and education records only for the purpose of performing its obligations under this Agreement, including but not limited to (1) evaluating, assessing and improving the performance of the Services provided to

JCPS; (2) implementing the 3DE Model at JCPS 3DE Schools as provided herein; and (3) tracking student progress. Notwithstanding any other term of this Agreement, 3DE will not disclose personally identifiable information or education records to any third party except as authorized by law. Should 3DE receive a subpoena or court order regarding the release of personally identifiable student information, 3DE will cause notice to be provided as required by FERPA and discussed in Article VI and will notify JCPS prior to releasing any personally identifiable Student information. JCPS may have access to student records with ten (10) business days' notice to 3DE as provided for in this Agreement.

Additionally, all employees, volunteers, and agents of 3DE will each sign a confidentiality agreement acknowledging these obligations before coming into contact with the 3DE's students. 3DE will take reasonable care with respect to the security of personally identifiable information and education records and will immediately notify JCPS if it becomes aware of or suspects any security or data breach with respect to personally identifiable information or education records.

With respect to information protected by FERPA, 3DE may not continue to maintain education records or personally identifiable information after termination of this Agreement. Unless otherwise agreed to in writing by the parties, within ten (10) business days of termination of this Agreement for any reason, 3DE must, as requested by JCPS, destroy or return to JCPS all data, education records, and personally identifiable student information.

3DE understands and agrees that JCPS is subject to the Open Records Act (ORA), O.C.G.A. § 50-18-70 et. seq., 3DE will cooperate with JCPS's requests for information required pursuant to the ORA as required by law, and 3DE understands and agrees that JCPS will respond to requests under the ORA at its discretion. However, 3DE may include a notarized affidavit stating with specificity any "trade secret" as that term is defined in O.C.G.A. § 10-1-761 to protect such confidential information from being automatically released under the ORA, specifically O.C.G.A. § 50-18-72(a)(34).

- 1.7. Accounting and Budgets. 3DE will be responsible for creating and maintaining a supplemental budget for the JCPS 3DE Schools, comprised of revenues raised by 3DE pursuant to Section 1.8, in compliance with Generally Accepted Accounting Principles (GAAP). The supplemental budget will cover spending by 3DE on JCPS 3DE Schools, including wages paid to the Director-3DE and the Partnership Manager-3DE, and any other expenditures made by 3DE to further JCPS 3DE Schools.
- 1.8. Fundraising and Acquisition of Community Resources. 3DE and JA of Kentuckiana will engage with businesses and local communities to raise funds and gather community resources to benefit 3DE. These resources will be used for the JCPS 3DE Schools in addition to the funds granted from JCPS funds as referenced in Section 2.2 of this document. 3DE and JA of Kentuckiana will reasonably attempt to secure all revenues necessary through grants and/or their general and customary fundraising efforts to fund their involvement and participation with JCPS 3DE Schools.

Section 2. Implementation by JCPS

- 2.1. **Program Policies and Operating Guidelines.** JCPS will develop, with 3DE input, all policies, procedures, and guidelines related to 3DE's interdisciplinary case methodology framework. JCPS will develop all other policies, procedures, and guidelines related to the operations and administration of JCPS 3DE Schools to ensure compliance with JCPS policies and practices.
- 2.2. School Revenues. JCPS will fund the JCPS 3DE Schools through allocation of general funds and funds for JCPS 3DE Schools. JCPS will be responsible for determining student enrollment in JCPS 3DE Schools and for the use and accounting of all federal funding earned by JCPS 3DE Schools. Funding allocated by JCPS to 3DE will be used solely for JCPS 3DE Schools.
- 2.3. Accounting and Budgets. JCPS will be responsible for creating and maintaining the main budget for JCPS 3DE Schools. This budget will be exclusively used in its entirety for JCPS 3DE Schools, including the required teacher allocation to execute and maintain model fidelity and transportation required for case experience culminations and consultancies in accordance with the Model Fidelity Framework in Addendum Three. JCPS will comply with all JCPS accounting requirements and procedures.
- 2.4. **Personnel.** JCPS will be responsible for the employment and management of all personnel of JCPS 3DE Schools, with the exception of the Director-3DE and Partnership Manager-3DE, who will at all times be employees of 3DE. JCPS will recruit and hire all qualified educational personnel and classified personnel for administrative and/or operational functions of JCPS 3DE Schools, with 3DE input in accordance with Addendum Two. These employees will meet 3DE and JCPS expectations as identified in Addendum Two. JCPS will also be responsible for the performance management of all JCPS 3DE Schools personnel, with the exception of the Director-3DE and Partnership Manager-3DE. If the Director-3DE believes the JCPS staff to be ineffective, unsatisfactory, or out of compliance with any provision of this Agreement, the Director-3DE will notify JCPS, identifying such conduct and providing support as necessary in writing. JCPS will promptly address the performance or conduct of the JCPS staff in accordance with JCPS policies. All personnel hired by JCPS 3DE Schools will be considered employees of JCPS. JCPS will comply with all applicable state and federal laws, State Board of Education rules, and JCPS policies and procedures related to human resource management and employment.
- 2.5. **3DE** Administrator. JCPS will hire/designate, with 3DE input in accordance with Addendum Two, at least one full time employee to serve as the 3DE Administrator henceforth known as the Assistant Principal. The Assistant Principal will be the chief administrator of JCPS 3DE Schools for JCPS. The Assistant Principal will be responsible for coordinating with the Director-3DE to implement all services and program components of JCPS 3DE Schools. The Assistant Principal will supervise and evaluate all JCPS 3DE Schools educational personnel, with the exception of the Director-3DE and Partnership Manager-3DE. The Assistant Principal position will be filled by a JCPS employee and will be paid for with JCPS funds.

- 2.6. **Professional Development.** JCPS will provide professional development related to general instructional support, curricular content, state academic and career preparation standards, school and classroom culture, and content delivery for all educational personnel of JCPS 3DE Schools.
- 2.7. **Curriculum.** JCPS will be responsible for ensuring the curriculum of all JCPS 3DE Schools is aligned to state academic and career preparation standards. JCPS will also develop, coordinate, and implement all curricular course offerings of all JCPS 3DE Schools. All JCPS courses offered through all JCPS 3DE Schools will be infused with 3DE developed interdisciplinary case methodology framework principles, enhancements, and student experiences, and 3DE educational personnel will meet weekly as an interdisciplinary team for common planning.
- 2.8. **Student Assessment.** Students enrolled in JCPS 3DE Schools shall take all state mandated assessments. These assessments shall be provided by JCPS. JCPS shall ensure that all assessments are administered in accordance with the Kentucky Department of Education rules and policies. JCPS will directly administer the assessments and will remain responsible at all times for testing materials, security, and administration.
- 2.9. **School Culture.** JCPS will be responsible for establishing a supportive school climate and culture dedicated to the core principles of JCPS 3DE School's interdisciplinary and case methodology framework focus.
- 2.10. **Student Conduct.** JCPS will be responsible for monitoring student conduct and implementing all appropriate disciplinary action as required.
- 2.11. **Records Maintenance.** JCPS will be responsible for the maintenance of all student and school records kept by JCPS 3DE Schools.
- 2.12. School Operations and Facility Maintenance. JCPS will be responsible for the coordination and implementation of all operations of JCPS 3DE Schools, including student nutrition, transportation, student health and safety, and emergency preparedness. JCPS will be responsible for all maintenance and upkeep of the designated facilities for JCPS 3DE Schools. JCPS will help enable 3DE staff access to necessary collaboration and communication platforms that support 3DE operations.
- 2.13. Regulatory Compliance and Safety. JCPS will ensure the compliance of JCPS 3DE Schools with all applicable state and federal laws, State Board of Education rules, JCPS policies and procedures for federal funding programs, and state accountability requirements, including all laws related to the health and safety of students, civil rights, and special education services. JCPS will monitor the compliance of employees, volunteers, and agents of JCPS 3DE Schools with these rules, laws, policies, and procedures, and will provide related guidance and training as necessary. JCPS may screen, in a timely manner and at JCPS cost, all employees, volunteers, or other agents of JCPS 3DE Schools through the JCPS's own processes and systems that come into contact with students of JCPS 3DE Schools to ensure student safety. The screening may include background checks, review of

resume/credentials, and may include participation in interviews and/or hiring prior to assignment to JCPS 3DE Schools.

2.14. **Permissions and Access.** JCPS will recognize 3DE as an authorized agent for JCPS and therefore, within a reasonable timeframe, will provide access to student and teacher data, subject to terms and conditions of the attached Data Sharing Agreement (Addendum Four and Schedule 2.14), for local operations and management to include the following: identified, student-level data for JCPS 3DE Schools students; de-identified student-level data for non- JCPS 3DE Schools students within the host school; and access for 3DE on-site personnel to Student Information Systems (SIS) that will facilitate access to said data. To ensure continual improvement and objectivity, access to said data will also be provided to a third-party evaluator, also in compliance with all FERPA parameters and subject to terms and conditions of the Data Sharing Agreement. 3DE will identify JCPS or JCPS schools in internal and external reports, including grant letters of intent; proposals and fundraising reports; partnership updates shared with the 3DE Board; existing/potential school district partners; existing/potential fundraising partners; and internal 3DE presentations. As mentioned in Section 1.6 above, 3DE will comply with all parameters of confidentiality under FERPA.

Section 3. Joint Obligations of 3DE and JCPS

- 3.1. Community Launch and Awareness. JCPS and 3DE will actively collaborate to develop appropriate strategies for outreach to potential students of JCPS 3DE Schools. 3DE will provide a library of resources for the district and school to utilize to generate awareness among the local community (school board, teachers, parents, and students). JCPS will be responsible for enrolling students in adherence to 3DE's standards of equity and mirroring strategy. To support early awareness and relationship building, 3DE will provide the first of two 3DE on-site personnel beginning the spring semester before school opening in the fall. The 3DE on-site personnel will assist the district/school with the enrollment process following their training/on-boarding.
- 3.2. Strategic Alignment. 3DE leadership (CEO) and JCPS leadership (Superintendent) will meet once per year to ensure alignment in the areas of strategic focus, student achievement, improvement, and financial resource allocation. If agreed upon mutually by both the 3DE CEO and the JCPS Superintendent, designees may serve in this capacity.
- 3.3. **Program Evaluation and Assessment.** The Program is to be evaluated based upon criteria agreed upon by both JCPS and 3DE sixty to ninety (60-90) days prior to the end of each academic year. The parties agree to meet periodically and/or by request to discuss and collaborate to resolve any issues or concerns with 3DE's operations, efficacy, or implementation. Any data shared with 3DE by way of program assessment and evaluation outside those measures already established by Kentucky Department of Education and JCPS will be de-identified to ensure FERPA compliance.

Section 4. Agreement Terms

- 4.1. **Term of Agreement.** The term of this Agreement shall be November 13, 2019 until June 30, 2026.
- 4.2. Renewal of Agreement. Approximately sixty to ninety (60-90) days prior to the end of each academic year, the parties will review the performance of the parties and the other factors involved in the operation of the Agreement. The parties retain the right to meet for this purpose. Following these discussions, the parties may (1) agree to continue with the Agreement on the same basis as the then current term, or (2) agree to continue with the Agreement for the current term, but upon different terms and provisions to be agreed upon by the parties and included as an amendment to this Agreement.
- 4.3. **Status of Employees.** The parties expressly agree that nothing contained in this Agreement will be construed to create an agency or employment relationship between 3DE, JA of Kentuckiana and JCPS or between any 3DE employees or JA of Kentuckiana employees and JCPS. 3DE employees will at all times be employees of 3DE. JA of Kentuckiana employees will at all times be employees of JA of Kentuckiana. JCPS employees will at all times be employees of JCPS. No party assumes any liability for any loss or injury resulting from (1) the acts and omissions of any other party, its directors, trustees, agents or employees or (2) any debt or contractual obligation incurred by any other party.
- 4.4. **Independent Contractors.** It is mutually understood by the parties that JCPS, 3DE, and JA of Kentuckiana, in performing their respective duties and obligations under this Agreement, are at all times acting and performing as independent contractors with respect to each other, and nothing in this Agreement is intended, and nothing in this Agreement shall be construed to create an employer/employee, partnership or joint venture relationship. No party shall have the authority to act on behalf of any other party, except as otherwise provided herein. Each party acknowledges that it does not have the authority to, and will not, extend the faith and credit of any other party to any third party.
- 4.5. **Affiliation.** Except as otherwise permitted in this Agreement, no Party shall use the name, logo, nor other copyrighted materials of any other Party in any promotion, advertisement or in any other way without the advance approved written consent of a qualified representative from such other Party. JCPS agrees that its use of the 3DE Brand or any JA of Kentuckiana mark, and any goodwill in the 3DE Brand or JA of Kentuckiana mark resulting from JCPS's use will not create any right, title, or interest for JCPS in the 3DE Brand or the JA of Kentuckiana mark.
- 4.6. Ownership and License of Work Product. All work product and deliverables used or created by 3DE and/or JCPS with respect to the 3DE Model or its implementation pursuant to this Agreement or otherwise related to the 3DE Model, whether partial or complete (collectively the "Work Product"), shall be owned by 3DE and may be used, licensed and sublicensed by 3DE, as so determined by 3DE; provided however that the JCPS curriculum and other JCPS Properties owned or provided by JCPS in connection with the development of the Work Product hereunder shall continue to be owned and used by

- JCPS. JCPS shall have no ownership rights in or to the Work Product apart from the JCPS Properties. Accordingly, JCPS hereby assigns and conveys, any and all right, title, interest, and other ownership in and to the Work Product, including all goodwill therein but excluding any and all interest in the JCPS Properties, to 3DE free of additional consideration. This assignment shall occur automatically upon the creation of any Work Product and upon any changes or additions thereto. Though such assignment is automatic under this Agreement, JCPS shall provide and execute all documents necessary to effectuate and record such assignment to 3DE upon request. To the extent any Work Product is not able to be transferred by JCPS to 3DE hereunder by operation of law, this Agreement or otherwise, then JCPS hereby grants and conveys to 3DE a perpetual, exclusive, transferable and sub-licensable license to use, reproduce, distribute, adapt, modify, translate, publicly perform and publicly display, in whole or in part, the Work Product and any and all modifications, enhancements or other derivative works thereof. JCPS represents, warrants and covenants to 3DE that (i) it has the right to grant and convey the foregoing assignment and license of the Work Product (ii) any Work Product provided by JCPS is and shall be free of all liens and encumbrances and (iii) that any Work Product created or provided by JCPS does not infringe the intellectual property rights of any third party.
- 4.7. Ownership and License of 3DE Properties. All 3DE Properties shall remain the sole property of 3DE, and JCPS acknowledges and agrees that it shall not, at any time, acquire any ownership rights, title or interest in the 3DE Properties, or derivatives or modifications thereof, by virtue of any use JCPS may make of such 3DE Properties and regardless of whether any such rights have been registered. Subject to the terms and conditions of the attached Schedule 4.7, 3DE hereby grants to JCPS, during the term of this Agreement, a nonexclusive and nontransferable royalty free right and license to use the 3DE Properties including the Work Product developed hereunder (as made available to JCPS), but only in connection with the establishment, operation and marketing of the JCPS 3DE Schools. 3DE acknowledges that such license includes the right of JCPS to publish or otherwise use descriptions of the Work Product or other 3DE Properties in its promotional materials during the term of this Agreement. Should this Agreement be terminated, JCPS acknowledges that it must receive the prior written consent of 3DE to use the Work Product or other 3DE Properties or any derivatives thereof. The rights with respect to the 3DE Properties are licensed and not sold to JCPS. The rights to the 3DE Properties are limited to the scope of this express license; there are no implied licenses. All rights and licenses not expressly granted under this Agreement are reserved by 3DE.
- 4.8. Ownership and License of JCPS Properties. All JCPS Properties shall remain the sole property of JCPS, and 3DE acknowledges and agrees that its shall not, at any time, acquire any ownership rights, title or interest in the JCPS Properties, or derivatives or modifications thereof, by virtue of any use 3DE may make of such JCPS Properties and regardless of whether any such rights have been registered. Subject to the terms and conditions of this Agreement, JCPS hereby grants to 3DE, during the term of this Agreement, a nonexclusive and nontransferable royalty free right and license to use the JCPS Properties (as made available to 3DE), but only in connection with the establishment, operation and marketing of the JCPS 3DE Schools, including the development of the Work Product hereunder. Furthermore, the parties acknowledge that certain JCPS Properties will be used by JCPS and 3DE in connection with creating the Work Product. Notwithstanding

any other provision of this Agreement, in the event that any JCPS Properties or part thereof are used in and comprise a part of the Work Product created or provided by JCPS, then JCPS hereby grants to 3DE a perpetual, royalty-free, transferable license to use such JCPS Properties or part thereof as part of the Work Product or 3DE Model, so long as (i) the JCPS Properties are not used by themselves separate and apart from the Work Product or the 3DE Model and revisions, enhancements and derivatives thereof, and (ii) all references or identifiers to JCPS are removed from the Work Product or 3DE Model and any revisions, enhancements or derivatives thereof.

- 4.9. **Delegation of Duties.** The parties agree and acknowledge that the functions and powers of each party may be exercised only by each party and may not be delegated to a third party without written agreement by the other party.
- 4.10. **Insurance.** Each party will obtain and maintain at its own expense insurance policies for general liability insurance and professional liability insurance from commercial insurance companies licensed to transact insurance in the State of Kentucky, in amounts, form, and carrier satisfactory to the parties, and shall, upon request, provide each other with copies of certificates of insurance as evidence of such coverage. If any party changes insurance carriers or has the coverage described herein decreased or terminated, such party will notify in writing the other party at least thirty (30) days prior to the expiration or termination of the current coverage.
- 4.11. **Cooperation.** Except where there is an actual or potential conflict of interest, 3DE, JA of Kentuckiana and JCPS shall cooperate in good faith in connection with any legal claim asserted against either of them in connection with the 3DE Model, and may, in their discretion, enter into a joint defense arrangement calling for the collective assertion of the joint defense privilege.
- 4.12. **Governing Laws.** This Agreement shall be governed by, subject to and construed under the laws of the State of Kentucky.
- 4.13. **Amendments to Agreement.** This Agreement may be amended by a writing signed by all parties.
- 4.14. **Breach of Agreement.** If any party is in material breach of its obligations under this Agreement, a non-breaching party may terminate this Agreement if the breach is not cured within thirty (30) days after the non-breaching party provides written notice of the breach to the breaching party, subject to the notice and termination provisions of Section 4.15 hereof.
- 4.15. **Termination of Agreement.** It is understood and agreed that because this Agreement is geared toward the academic year of teaching, educational services for students, and the employment of teachers, unilateral termination without due notice during the term of this Agreement is not appropriate. Therefore, the parties agree to provide the other parties with sixty (60) days advance notice of termination of this Agreement. Should any party breach a material term of the Agreement that endangers student or school employee safety, the Agreement may be terminated at once. Notice of any termination shall

be in writing and shall be deemed to have been given as of the date and time that it is (1) hand delivered, (2) delivered by the United States Postal Services, Certified Mail, return receipt requested, postage pre-paid, (3) delivery is completed by a nationally recognized overnight delivery company, or (4) delivery is made by facsimile and evidence of such transmission is retained by the sender. Should 3DE be unable to fund its involvement in JCPS 3DE Schools through securing of grants and/or their general and customary fundraising efforts, the parties will meet to discuss whether termination of the Agreement is appropriate.

- 4.16. Severability. In the event that any provision of this Agreement or the application hereof to any person or in any circumstances shall be determined to be invalid, unlawful, or unenforceable to any extent, the remainder of this Agreement and the application of such provision to persons or circumstances other than those as to which it is determined to be invalid, unlawful or unenforceable, shall not be affected thereby, and each remaining provision of this Agreement shall continue to be valid and may be enforced to the fullest extent permitted by law.
- 4.17. **Entire Agreement.** This Agreement, including the preamble and recitals which are hereby incorporated by reference, constitutes the entire understanding between the parties and supersedes all other agreements, whether written or oral, concerning the subject matter thereof and specifically supersedes the previous agreement between JCPS and Junior Achievement of Kentuckiana.
- 4.18. **Official Contacts for Agreement.** This Agreement, which shall be effective as of November 13, 2019, has been executed on behalf of:

Schedule A

Definitions

- "3DE Brand" means (i) the brands, logos, trademarks, service marks, trade names, commercial symbols, and other proprietary property developed and owned by or for 3DE National for use in connection with the 3DE Model, including without limitation "3DE" and (ii) all goodwill associated with the foregoing.
- "3DE Materials" means materials in physical, digital or any other format relating to or used in connection with 3DE Programs designed to educate and train youth in the concepts and practices of work readiness, entrepreneurship, financial literacy, business, ethics, and any related economic-based content, including without limitation educational and instructional materials and methods, designs and color schemes for curriculum and promotional materials prepared and distributed in relation to the 3DE Materials, other materials and specifications for certain products, and methods of operation, including manuals covering business practices and policies. It may include materials developed by 3DE National and any affiliate of 3DE National.
- "3DE Programs" means curriculum, events, experiences, programs, processes, and activities in every form whatsoever relating to the 3DE Model and may include those developed by 3DE National or any affiliate of 3DE National or others licensed to use 3DE Properties.
- "3DE Properties" means collectively, (a) 3DE Brand, and (b) 3DE Programs and 3DE Materials owned by or licensed to 3DE National, including without limitation the 3DE Model.
- "JCPS **Properties**" means the JCPS Brand, and the specific curricular content and programs (including without limitation the curriculum for the core subjects of English, math, history and social studies), state academic and career preparation standards, school and classroom culture, and content delivery for educational personnel, in every form whatsoever relating to educating youth as owned by, licensed by, other than those used under the licenses in this Agreement, or used by JCPS, whether in physical, digital or any other format. For purposes of this Agreement, it is acknowledged that JCPS obtains, licenses or uses various curriculum provided by third parties, and all such curriculum provided by JCPS for use in connection with developing the Work Product shall remain owned by JCPS or the applicable third party that provided such curriculum to JCPS.
- "JCPS Brand" means the brands, logos, trademarks, service marks, trade names, and other proprietary symbols for use in JCPS's operation of schools.

Schedule 4.7

Terms and Conditions for Use of Licensed 3DE Properties

- 1. JCPS accepts the license granted in Section 4.7 under the terms and conditions of this Agreement and agrees that it shall only use the 3DE Properties in the manner described in this Agreement. JCPS further covenants and agrees that:
- (a) it will not sell, donate, rent, lease, copy, loan, distribute, transfer, assign, license, sublicense, the 3DE Properties to any third party, or authorize or permit any third party to use the 3DE Properties without the prior written consent of 3DE;
- (b) it will not use the 3DE Properties other than in connection with and in furtherance of establishing, marketing and operating the JCPS 3DE Schools, and it will not authorize or permit the 3DE Properties to be used in any manner that reflects unfavorably upon the good name, goodwill, reputation or image of 3DE or its affiliates, 3DE National, JA Worldwide or Junior Achievement USA;
- (c) it will use variations, modifications or derivatives of the 3DE Properties only if it obtains the prior express written consent of 3DE;
- (d) it will respect and comply with all applicable national and international trademark and copyright laws in connection with any use of the 3DE Properties or any portion thereof;
- (e) it will not, during the term of this Agreement or thereafter, attack, challenge or dispute the title or any rights of 3DE or its affiliates in and to the 3DE Properties, and all derivatives and modifications thereof, and this provision shall survive the termination of this Agreement;
- (f) it will not, during the term of this Agreement and at any time thereafter, adopt or use any brand or marks that are confusingly similar to, or a simulation or colorable imitation of, the 3DE Brand, and this provision shall survive the termination of this Agreement;
- (g) it will promptly notify 3DE in writing in the event it learns of any infringement of any of the 3DE Properties by JCPS or any third party;
- (h) if requested by 3DE, it will cooperate with 3DE to protect, monitor and defend the 3DE Properties;
- (i) it will provide copies of all Work Product in the possession or control of JCPS to 3DE upon request; and
- (j) it will use the 3DE Properties in compliance with all applicable local, state and federal laws.
- 2. Should any right, title, interest, or other ownership in the 3DE Properties become vested in JCPS by operation of law, this Agreement or otherwise, JCPS agrees to assign, and hereby assigns, all such right, title, interest, and other ownership, including all goodwill therein, to 3DE free of additional consideration. Though such assignment is automatic under this Agreement, JCPS will, upon request, provide and execute all documents necessary to effectuate and record such assignment to 3DE.

Addendum One

JCPS 3DE Schools

In accordance with the Memorandum of Agreement ("Agreement" or "MOA") between Jefferson County Public Schools ("JCPS") and 3DE, JCPS seeks to implement the 3DE Model at selected high school(s) in JCPS as agreed with 3DE, with 3DE to open in the 2021-2022 school year.

All terms and conditions of the Agreement shall apply to the JCPS 3DE Schools.

The JCPS 3DE Schools opening in the 2021-2022 school year shall serve as the initial lead school(s) within JCPS with the potential and desire to replicate and expand into additional schools as part of a five-year strategic plan, which will be mutually agreed upon by JCPS and 3DE.

Addendum Four

Data Sharing Agreement

This Data Sharing Agreement ("DSA" or "Agreement") is entered into as of the signature date of the Memorandum of Agreement between Jefferson County Public Schools ("JCPS") and 3DE.

Section 1. Data Sharing

- 1.1 **Scope and Purpose.** JCPS agrees to share with 3DE the following data for JCPS students who are currently participating in 3DE programs in order to allow 3DE to serve the students in 3DE to evaluate the 3DE programs:
 - See Schedule 2.14 that is attached hereto and incorporated into this Agreement.
- Data Collection. Data will be provided within a reasonable time upon request in a manner deemed appropriate by JCPS to the designated representatives of 3DE as follows/ Representatives will be designated in writing by the parties (see Schedule 2.14 for designated representatives).

All requests to JCPS shall be directed to:

Ownership of Data. JCPS retains all ownership rights in all JCPS data, education records and personally identifiable student information provided to 3DE. Notwithstanding any other term of this Agreement, 3DE will not disclose JCPS data, personally identifiable information or education records received in any manner to any third party except as permitted by the District and 34 C.F.R. 99.33(a). JCPS may have access to student records maintained by 3DE with ten (10) business days' notice to 3DE at no charge to JCPS. 3DE will provide JCPS a copy of all evaluation reports or results within ten (10) business days of completion.

With respect to information protected by FERPA, 3DE may not continue to maintain education records or personally identifiable information of students after termination of this Agreement. Unless otherwise agreed to in writing by the parties, within ten (10) business days of termination of this Agreement for any reason, 3DE must, as requested by JCPS, destroy or return to JCPS all data, education records and personally identifiable student information.

Section 2. Student Records

This DSA applies to the collection and use of all JCPS student data by 3DE and represents the minimum care required with respect to JCPS student data. 3DE warrants and shall ensure that all affiliated entities, employees, contractors, agents, and representatives will hold such information in strict confidence and not disclose such information to third parties, except to the extent required by law, will be bound to comply with this DSA. To this end, the parties will advise each of its affiliated organizations, employees, agents, and representatives to keep such information confidential.

- 3DE and its affiliated organizations shall comply and shall assist JCPS in compliance, in all material respects, with federal and state laws and regulations regarding privacy of information and confidentiality of student records, including, without limitation, the Family Educational Rights and Privacy Act (FERPA), 20 U.S.C § 1232g, and the Protection of Pupil Rights Amendment (PPRA), 20 U.S.C. § 1232h.
- JCPS designates 3DE as "authorized agent" within the meaning of FERPA, as the services provided to JCPS by 3DE are functions that would normally be provided by JCPS, including enrichment services and programs for students in JCPS and the evaluation of those programs and services. 3DE have a legitimate educational interest in student educational records and information. 3DE will be under the direct control of JCPS data, with respect to the use and maintenance of JCPS personally identifiable information and education records, as those terms are defined by FERPA. 3DE may use JCPS personally identifiable information and education records only for the purpose of performing obligations to JCPS to evaluate or provide programs and services to JCPS in accordance with this DSA.

Section 3. Data Security

- 3.1 **Privacy, Confidentiality, and Security.** 3DE understands and agrees that it is imperative to protect JCPS data in order to protect public resources and to prevent identity theft or other malicious and damaging acts. 3DE shall comply with all applicable federal, state, and local laws, rules, and regulations, as the same may be amended or supplemented from time to time, including but not limited to those pertaining in any way to the privacy, confidentiality, security, management, and disclosure of JCPS data and information. 3DE shall also adhere to all applicable industry standards concerning privacy, data protection, confidentiality and information security as well as all JCPS policies, procedures, and operating guidelines regarding privacy, confidentiality, and security.
- Protection of Data. 3DE shall take all commercially reasonable measures necessary to keep the JCPS data confidential, including, without limitation, all measures it takes to protect its confidential information of a similar nature. Without limiting the effect of the preceding sentence, 3DE will take commercially reasonable actions, legal or otherwise, necessary to cause its representatives to comply with the provisions of this Data Sharing Agreement and to prevent any disclosure of JCPS data by any of them.
- 3.3 Notice of Data Breach. 3DE shall give prompt written notice to JCPS of any suspected or actual security breach that may or does impact JCPS data or of any unauthorized use or disclosure of JCPS information. 3DE shall assist JCPS in remedying each unauthorized use or disclosure at 3DE'sexpense. Giving assistance does not waive any breach of this Data

- Sharing Agreement by 3DE, nor does acceptance of the assistance constitute a waiver of any breach of this Data Sharing Agreement.
- 3.4 **Breach of Data Sharing Agreement.** 3DE acknowledge and agrees that an award of money damages is inadequate for any breach of this Data Sharing Agreement by 3DE, or any of their respective agents, representatives, administrators, employees, officers, directors, attorneys, successors and assigns; and that any breach causes JCPS irreparable harm. Therefore, in the event of any breach or threatened breach of this Data Sharing Agreement by 3DE or any of their representatives, JCPS is entitled to equitable relief, including injunctive relief and specific performance, without proof of actual damages and without the posting of a bond.
- 3.5 **Modification**. No modification of this DSA will be valid unless in writing and executed by authorized representatives of all Parties.
- 3.6 **Use of Contractors**. No contractors or assignee are permitted by use by 3DE without specific written agreement of JCPS.
- 3.7 **Choice of Law**. This DSA shall be interpreted, construed and given effect in all respects according to the laws of the State of Kentucky. The exclusive venue for any action arising out of or related to this Agreement shall be in the federal, superior, or state courts of Kentucky, and the Parties waive any and all objections to such venue.
- 3.8 **Severability**. The invalidity of any provision of this Agreement will not affect the validity of any other provision.
- 3.9 **Research**. Except as otherwise agreed, including in Section 1.6 of the Memorandum of Agreement, this DSA does not authorize 3DE to conduct research with JCPS data, students or staff. All research must be separately approved pursuant to JCPS Policy ICC.
- 3.10 **Term and Termination**. This Agreement will automatically terminate upon the termination of all programs in operation in partnership between 3DE and JCPS. This Agreement may be terminated by JCPS with thirty days written notice to 3DE
- 3.11 **Publications.** 3DE shall have the right, at their discretion, to release, discuss, or publish research findings resulting from the research study or to use research findings for its educational and research purposes, provided that publication and use do not violate the terms of this agreement. Any data published shall be presented in aggregate statistical form only.
 - The District hereby provides written approval for 3DE to identify the District or District schools in grant letters of intent; proposals and fundraising reports, partnership updates shared with the 3DE Board; existing/potential school district partners; potential/existing fundraising partners; and internal 3DE presentations.

The MOA is between the School District and 3DE, with the Junior Achievement (JA) Area as a signatory to note the authorization for 3DE to enter into contract with the District. 3DE is listed as a Special Purpose Entity formed by 3DE National for the purpose of operating in a particular state. While 3DE and the District have the responsibility of fulfilling the contract, the JA Area is a co-signer to demonstrate the collaboration that exists between 3DE and the JA Area, e.g., activation of business partners and fundraising.
