I hope you are doing well today and are having a nice week.

My name is Alex Short and I work with Rosstarrant Architect. Our office is currently working with the Elizabethtown Independent School District on a DFP finding to add a CTE building for the High School Campus. We have worked through some initial diagram and CTE program planning with the district to develop an initial plan. I wanted to reach out and share the programs that are being proposed as well as the current schematic lay out that we have developed for the space, for your initial review based on the programs in and around the area.

We are currently proposing the below as programs to be included in this CTE space.

- Business Education Technology – Net Area 2,462 SF.
- Construction Technology – Net Area 4,399 SF
- Engineering Technology Education – Net Area 3,876 SF
- Health Science – Net Area 2,586 SF
- Welding Education – Net Area 5,476 SF

Please find a rough schematic floor plan attached to this email as well. This is an initial exploration of how these spaces could be programmed, but is not a final lay out at this point in time.
