Division 02: Existing Conditions

02.01: 2023.05.31 – The thrust stage walls had been lowered to the new level.

02.02: 2023.06.14 – Second floor demolition was apx. 90% complete. Cleanup was occurring where the exterior masonry walls of the auditorium had been removed.

02.03: 2023.06.14 – Pavement removal and milling at the Taylor Mill site was complete. Work was on-going at an existing fire hydrant to be relocated. The ramp outside the cafeteria had been removed.

Division 03: Concrete

03.01: 2023.05.31 - First floor plumbing trenches had been backfilled, poured, and finished.

Division 04: Masonry

04.01: 2023.05.31 – CMU walls were actively being installed under the auditorium seating bowl. 04.02: 2023.06.14 – 2" masonry soaps were being installed at the base of walls in Area C. Area A wall construction was actively occurring at the concession storage room.

Division 08: Doors and Windows

08.01: 2023.05.31 – Glass had been installed at the East curtain wall of the pool space. Several panes were identified as being incorrect.

08.02: 2023.06.14 - Cap trim was being installed on the East curtain wall.

Division 09: Finishes

09.01: 2023.05.31 – Roof structure in the pool space had been partially painted with at least a first color coat. Tile installation was on-going at the 2nd floor restrooms in Area C (grouting). 09.02: 2023.06.14 – Painting was on-going in the pool space.



Division 10: Specialties

10.01: 2023.06.14 – Metal locker installation was largely complete, with inside corners of sloped tops needing completion. Locker room benches were observed.

Division 11: Equipment

11.01: 2023.05.31 – Basketball goals and scoreboards were installed in the main gym. Scoreboards had been installed in the practice gym.

Division 13: Special Construction

13.01: 2023.05.31 – Blue duct installation had begun under the pool deck. Stainless steel gutter installation was largely complete. Backfill at the north end of the pool was largely complete and had turned southward along both sides of the pool.

13.02: 2023.06.14 – Installation of the blue duct was largely complete, but an issue during backfilling resulted in the need to remove backfill material and make some adjustments to both the duct and the backfill procedure.

Division 20-28: MEP

20-28.01: 2023.05.31 – Most light fixtures in the main gym were functioning.

20-28.02: 2023.05.31 – A crane was staged for removal of equipment from the Woodland mechanical room. Plumbing carriers had been installed at first floor restrooms.

20-28.03: 2023.06.14 – Plumbing carrier assemblies were staged at the second floor for installation. Piping installation had progressed at first floor carriers.

20-28.04: 2023.06.14 – Dehumidification was occurring in many Area C spaces in preparation for flooring acclimatization and installation. Heat pump installation in Woodland was on-going. It appeared most existing units had been removed. New units were staged for installation with several new units having been installed.

Division 31: Earthwork

31.01: 2023.05.31 – Topsoil placement and final grading were actively occurring south of the baseball field.

31.02: 2023.06.14 - Areas outside of the baseball field had been seeded and strawed.

Division 32: Exterior Improvements

32.01: 2023.05.31 – Tennis court surfacing materials were delivered to the site in preparation for installation.

32.02: 2023.06.14 - Sidewalks had been poured between Scott and Woodland.

32.03: 2023.06.14 – Tennis court surfacing was actively occurring. The crew anticipated striping would be complete by end of day.

32.04: 2023.06.14 – Fence posts were installed around the Scott detention basin.


32.05: 2023.06.14 - Several additional storm structures had been installed, piped, and backfilled.






