**Recommendation/Motion:** Approve a revised BG-1 Project Application for the construction of New Middle School on Polo Club Boulevard, in the amount of \$81,778,999.75 (Eighty-one Million, Seven Hundred Seventy-eight Thousand, Nine Hundred Ninety-nine Dollars and Seventy-five Cents).

**Background/Rationale:** A revised BG-1 Project Application for the bid/construction, identifying the extent and cost of the work, was approved by the Board at its September 26, 2022 meeting. This revised BG1 reflects the actual costs and revenue associated with the post-bid bond sale. This revised BG1 does not require new funds to be approved by the Board. Based on this KDE requirement, a revision to the BG-1 is required as follows:
