**Recommendation/Motion:** Approve a revised BG-1 Project Application for the construction of the Combined CTE School at Midland Avenue in the amount of \$64,653,479.85 (Sixty-four Million, Six Hundred Fifty-three Thousand, Four Hundred Seventy-nine Dollars and Eight-five Cents).

**Background/Rationale:** A revised BG-1 Project Application for the bid/construction, identifying the extent and cost of the work, was approved by the Board at its November 28, 2022 meeting. This revised BG1 reflects the actual costs and revenue associated with the post-bid bond sale. This revised BG1 does not require new funds to be approved by the Board. Based on this KDE requirement, a revision to the BG-1 is required as follows:
