After one year of implementing this program we have revised aspects of what our transcripts look like based on information provided that was inhibiting our students, over 400 consultations (phone and in-person) have occurred with parents and students directly and all three high schools, and monthly sessions with students in large groups, one-on-one, and small groups. This coaching plan aligns with our Board Aspiration statements of "Assure our graduates are ready to immediately succeed in life" and "Collaborate with businesses, education providers, and the community to maximize student learning options". of The renewal costs will be \$173,250.00 and will be funded through Title IV, BEAM, and/or student learning funds.
