





- 2.) Can Soccer lines be gray instead of yellow? Yes, no problem (no cost change)
- 3.) Can a color be added inside the striping at the two player boxes at each sideline? The owner would like the endzone color to match these player boxes. Yes would be a change order as colors are slightly more cost than green.

- 4.) It looks like the soccer stripping differs at East where it cuts through the endzone lettering but then at North and Central it sits be above the endzone lettering. Each field layout should be the same. Let me know if we need to revise something at the East field. Soccer dimensions match drawings I can have these changes made to make them all the same (no cost change)
- 5.) BCPS would like to add practice stripping at the plan left side of the East field. I can send that over to you later this morning. Ok would be a change order for the additional striping.


