National School Lunch Program Updates

Information in this section pertains to sponsors that participate in the National School Lunch Program, School Breakfast Program, Afterschool Snack Program, Special Milk Program and Seamless Summer Option.

Adult Meal Price for SY 23-24

Sponsors are required to price nonprogram meals sold to adults in accordance with FNS Instruction 782-5 Revision 1. Any meal sold to an adult must be priced to meet the minimum required price to ensure that no federal child nutrition funds are subsidizing adult meals. This is effective from the beginning of the school year and applies to all adult meals. [The SCN Adult Meal Price Calculator](#) is updated and available on SponsorNet. Also, the [SY 2023-2024 Adult Meal Price Presentation template](#) is available on SponsorNet. The Adult Meal Price Presentation template is a customizable template for Sponsors to use to assist with presenting the Adult Meal Price to the Board of Education so that members have an understanding of the program requirements. It is important to note that pricing sites and non-pricing (CEP) sites use different formulas to determine the minimum required price.
