### **AGENDA ITEM (ACTION ITEM):**

Consider/Approve the School Resource Officer contracts for the 2023-24 school year, including a mutually agreeable three-year automatic renewal clause, with the City of Edgewood, City of Independence, Kenton County Fiscal Court, Kenton County Sheriff's Office, and City of Villa Hills.

### **HISTORY/BACKGROUND:**

The District continues to partner with local police agencies to supply School Resource Officers (SRO) to all KCSD schools. In an effort to expedite the contract renewal process with the five agencies supplying SROs, a contract containing a mutual three-year renewal option was developed. This contract contains a fixed salary contribution amount of \$35,500 per SRO from the District to each agency for the 2023-24 school year while also establishing a fixed percentage increase of 3% per SRO for each year of the renewal period. This brings consistency to the District's investment in safety and provides for accurate long-term budgeting of the SRO program.

### FISCAL/BUDGETARY IMPACT:

\$603,500 from the general fund for the 2023-24 fiscal year (\$35,500 x 17 SROs).

#### **RECOMMENDATION:**

Approval to enter into contracts for School Resource Officers for the 2023-24 school year, to include a mutually agreeable three-year automatic renewal clause, with the City of Edgewood, City of Independence, Kenton County Fiscal Court, Kenton County Sheriff's Office, and City of Villa Hills.
