As requested, we have calculated a "worst case scenario" totaling \$206,000 (Aug-May) for the rental service for temporary cooling, not including installation changes from other contractors or heat. The district will not be billed a lump sum from Aggreko but a monthly rental cost. Initially we are forecasting approximately \$37,000 in August, and \$18,000 each month thereafter until the unit is no longer required, with a slightly larger last month cost for "cleanup".
