

# **Event Contract**

This agreement is made between Bi-Okoto Drum and Dance Theater hereinafter referred to as "Bi-Okoto" and the Piner Elementary School, of 2845 Piner Ridge Road, Morning View, Kentucky 41063 hereinafter referred to as "the client". The parties hereby agree to the following terms and conditions.

#### I. SERVICES

On 2024-04-01, Bi-Okoto artist(s) shall render the following services: (1) 45 Minutes "Rhythms of Our Land" with 15 minutes Q & A

#### II. PAYMENT

In exchange for services provided, the client will pay Bi-Okoto the amount of \$750. A minimum of 50% is due as deposit upon receipt or 30 days before the event, (whichever is later), to secure event dates. The balance should be delivered to a Bi-Okoto representative on the day of the event. Checks should be made payable to Bi-Okoto - F.E.I.N. #31-1440549.

#### III. TECHNICAL REQUIREMENTS

The client shall provide the following requirements to Bi-Okoto artists:

Event area approximately 30' x 30' or more (no concrete or grass surfaces)

3 - 6 chairs without arms

2 - 4 standing microphones or lavaliers

Secured changing area with restrooms.

Water, juice, and some meals for the artists (as necessary)

#### IV. MISCELLANEOUS

Videotaping of the event or the use of photography (specifically flash photography) is strictly prohibited without the consent of Bi-Okoto prior to the event. If the event is canceled due to inclement weather and/or school closing, Bi-Okoto will make all efforts to reschedule the event with a reasonable and agreed upon timeframe with the client. Any monies paid would be applied to the rescheduled event.
