This contract is entered for the school year starting July 1, 2023 through June 30, 2024 between the Russellville Independent Schools located at 355 S Summer Street Russellville, KY 42276 and Logan Memorial Hospital, LLC ("Logan Memorial") located at 1625 Nashville Street, P.O. Box 10, Russellville, KY 42276. Logan Memorial agrees to supply Russellville Independent Schools a physical therapist one to two days a month to administer school-based services. Scheduling will be agreed to by both parties in advance, on a monthly basis.

The Russellville Independent Schools agree:

- 1. To pay Logan Memorial at an hourly rate of \$33/hr for hours worked as submitted by the physical therapist assistant ("PTA").‡
- 2. Work performed will be performed in accordance with the board description specific to the job title.
- 3. To provide access to appropriate state laws, state regulations, and the District's policies specific to the PTA's responsibilities and role.
- 4. To provide an environment of cooperation between all personnel to allow the PTA-to perform his/her role.
- 5. To provide appropriate job performance assessment as required by the District and access to Logan Memorial to a copy.
- 6. To provide adequate space for the PTA to provide the physical therapy services, including space that ensures the privacy and confidentiality of the treatment and compliance with HIPAA and FERPA, as defined below.
- 7. To provide Logan Memorial and its PT access to all records created as a result of the services rendered to PTA-pursuant to this Agreement.

Logan Memorial agrees to:

- 1. Maintain a <u>physical therapy</u> program which is licensed, and which is eligible to receive public education funds.
- 2. Provide <u>physical therapy</u> services that meet the state education standards for preschool programs.
- 3. Submit bills for agreed-upon cost of service to the school district on a monthly basis.
- 4. Provide a liaison to the school district for matters of mutual concern.
- 5. Provide a representative to participate in the Individual education plan (IEP) development and the PTA to provide appropriate physical therapy services as defined on the IEP and this Agreemente.
- 6. <u>Logan Memorial</u> agrees to fulfill all employment requirements established by the district, including but not limited to background checks, child abuse and neglect checks, physical exams (if required for position).
- 7. <u>Logan Memorial</u> will maintain documentation of all requirements for employment <u>of the PTA</u> (licensure, certifications, etc.....) and provide copies to the district upon request.

Mutual agreement between Russellville Independent Schools and Logan Memorial:

1. The contract may be renewed by the parties at the end of each fiscal year.
