Discussion: Chief Middle School Leadership Officer Bill Bradford shared the proposed name of the middle school under construction on Polo Club Boulevard recommended by a committee that included a committee of 12 community members, including principals and family representatives from elementary schools in the area. The group's recommendation is Mary E.

Britton Middle School. Britton was an American physician, educator, suffragist, journalist, and civil rights activist who was born and raised in Lexington. Among her many accomplishments, Britton taught in Lexington's segregated schools before becoming a physician. She specialized in hydrotherapy, electrotherapy, and massage, and was officially granted her license to practice in 1902, making her the first female doctor to be licensed in Lexington.
