#### AWARD OF BIDS/PROPOSALS

#### 1. Bid 41-23 Janitorial Supplies Catalog Contract

#### **BACKGROUND AND RATIONALE:**

This RFP is used to establish a multiple award janitorial supplies contract for Grounds and Custodial Support to use for ordering supplies for all district custodial staff. Proposals were evaluated and scored based on pricing on 79 different items ordered by the district, discount on other items available from the vendors, as well as other things such as references, delivery time and dedicated local sales representatives. After scoring all proposals the Grounds and Custodial Support staff decided to award the RFP to the top 5 scores to provide the best value to the district. Some of the vendors not in the top 5 have contracts with the Kentucky Purchasing Cooperative and can be used if needed. The RFP includes the option to renew on an annual basis upon Board approval.
