RE: Incident IQ Faciliites Ticketing System

Last school year I collected mini-bids to choose a work order system for our Maintenance Department. According to the decision matrix and what we had seen, we chose One To One Plus which had promised many things. We have recently decided that their lower cost (which was a deciding factor) wasn't worth the trouble that we've had. Our custodians and maintenance technicians have had difficulties with the mobile app over this time and it has even been down on several occasions. Our maintenance technicians only work from a mobile device that that can cause some major workflow issues.

It's only been a year since going with their product. However, a competitor that was slightly higher and charged a larger onboarding fee, has a much more polished, advanced system. Through discussions and demos with the company, Incident IQ. Danny Clemens, George Brock and I have decided that they would be the better option going forward. Dr. Bacon and I have also had conversations on choosing a product that will align more to our growing technology demands as a district. Going forward, their full system will replace the technology work order system with added cost. This will add a user password management portal and an asset management system as well.

For now, only going with the Facilities side of IIQ will cost us \$22,026.69, which includes the one-time \$3150 implementation cost. The quote is attached.
