Mr. Lindsey Clark, Board Vice-Chair, called the meeting to order at 5:30 P.M. and read the following Notice of Hearing:

Christian County Board of Education will hold a public hearing in the Christian County Board of Education meeting room on August 17, 2023 at 5:30 p.m. to hear public comments regarding a proposed general fund tax levy of 42.2 cents on real property and 42.8 cents on personal property.

The General Fund tax levied in fiscal year 2023 was 42.2 cents on real property and 42.8 cents on personal property and produced revenue of \$18,664,772.59. The proposed General Fund tax rate of 42.2 cents on real property and 42.8 cents on personal property is expected to produce \$20,346,605.73. Of this amount, \$3,081,355.87 is from new and personal property. The compensating tax rate for fiscal year 2024 is 40.5 cents on real property and 40.5 cents on personal property and is expected to produce \$19,489,979.75.

The general areas to which revenues of \$1,681,833.73 above 2023 revenues are to be allocated are as follows: cost of collections \$50,455; building fund \$84,092; maintenance \$1,547,286.73.
