TERMS

Terms are 30 days net from date of invoice unless otherwise specified. All terms are F.O.B. shipping point. ACCEPTANCE

The foregoing Statement of Work and these Terms and Conditions are accepted by signing the Confirmation above or by issuing a purchase order with the WARE Quote # listed on the foregoing Statement of Work. These Terms and Conditions and the foregoing Statement of Work shall not be modified or altered in any way unless done so in writing and signed by WARE.

DELIVERY

All delivery dates are approximate and deliveries are contingent upon strikes, fires, accidents, governmental action, or any other causes beyond our control.

WARE will ship orders to the customer by means we deem most expedient and least expensive unless the customer's order contains specific shipping instructions.
