Thanks so much for taking my call today. As I mentioned the boys' basketball team at Todd Co Central High School is growing. We area program that usually has 15-18 players on the team, but we expect 22-23 players to make up a Freshmen, JV, and Varsity team. With that, we need additional locker space for our locker room. We currently have 17 lockers and would like to add 11 more lockers so that our players have a place to secure their personal belongings during practice, games, etc.

Of course, with the addition of new lockers there is a cost involved. A new set of lockers designed to fit a specific area of our locker room will cost approximately \$3,500 (not including shipping) We are seeking financial assistance to make this purchase.
